Description

One High Street Windsor is an iconic building situated on the corner of Sheet Street, the High Street and Park Street. Park Street provides access to The Long Walk and the entrance is within 150 yards of the offices. The offices are at ground first and second floor levels, airconditioned, served by a bright contemporary reception area and attractive staircase. Parking is immediately to the rear of the building.

Location

The property is in Windsor High Street, a popular location within a few hundred yards of The Castle, amongst the shops / restaurants and within a short walk of both Windsor's train stations, as well as an easy drive to the M4 via the Windsor Relief Road or Heathrow and the M25 via Old Windsor.
