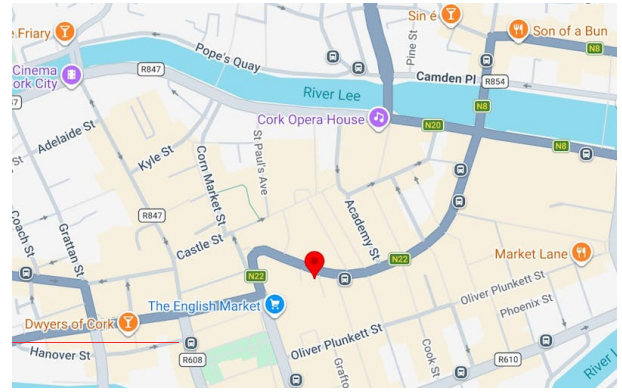
Specification

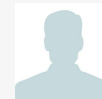

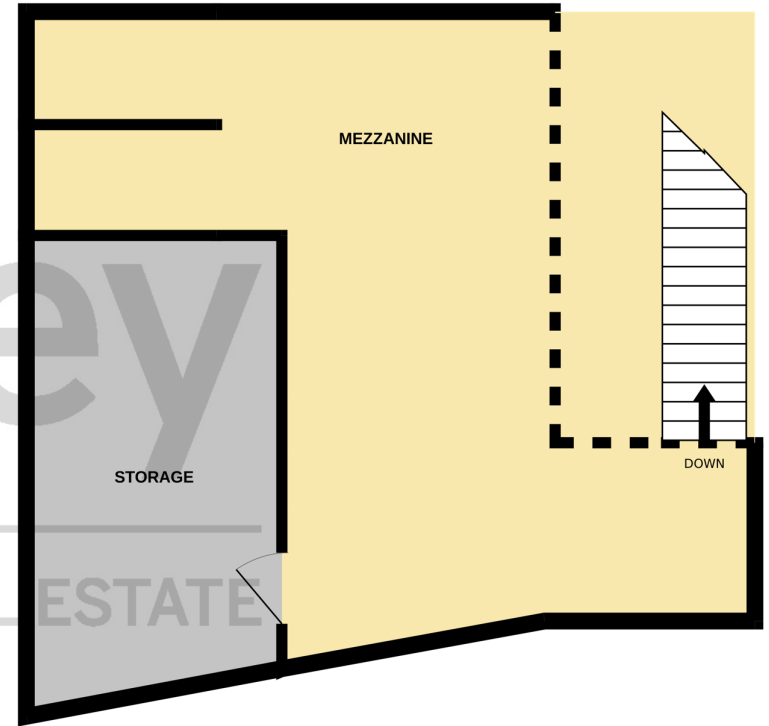
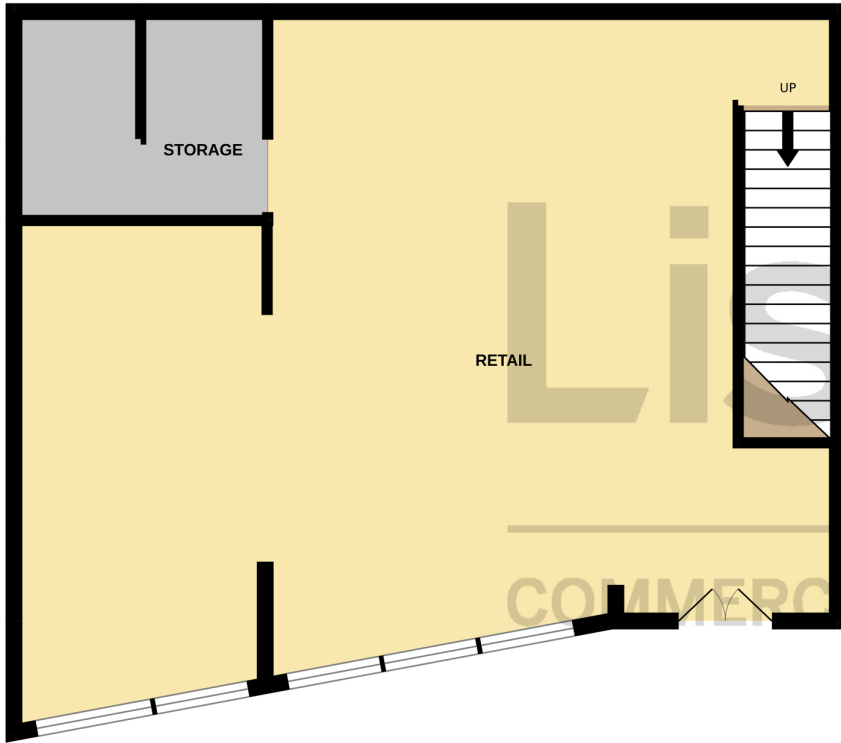
