

Situated on Mare Street. Hackney Central and London Fields has long been a destination for creative businesses. Hackney Central Station is a two minute walk to the north and prominent local venues including the Hackney Picture House and Hackney Empire theatre, plus the shops and restaurants of Mare Street and Lower Clapton Road.

Broadway Market is another popular retail location within walking distance with a varied mix of culinary produce, locally crafted beers and roasted coffee, vintage clothing, design wares and much more. The local area is set for further development around the Hackney Fashion Hub with multi-storey retail outlets, a restaurants and a sky bar.


Transport Links
