LOCATION

The property is located on the north side of John Knox Street close to its junction with Hamilton Street, just off Glasgow Road (A814). Glasgow Road (A814) forms part of the main arterial route through Clydebank. This stretch of Glasgow Road (A814) is a busy vehicular route linking Clydebank with Glasgow to the east and Dumbarton to the west. The new Renfrew Bridge takes less than 2 minutes drive to reach and Yoker Train Station takes less than 5 minutes walk.

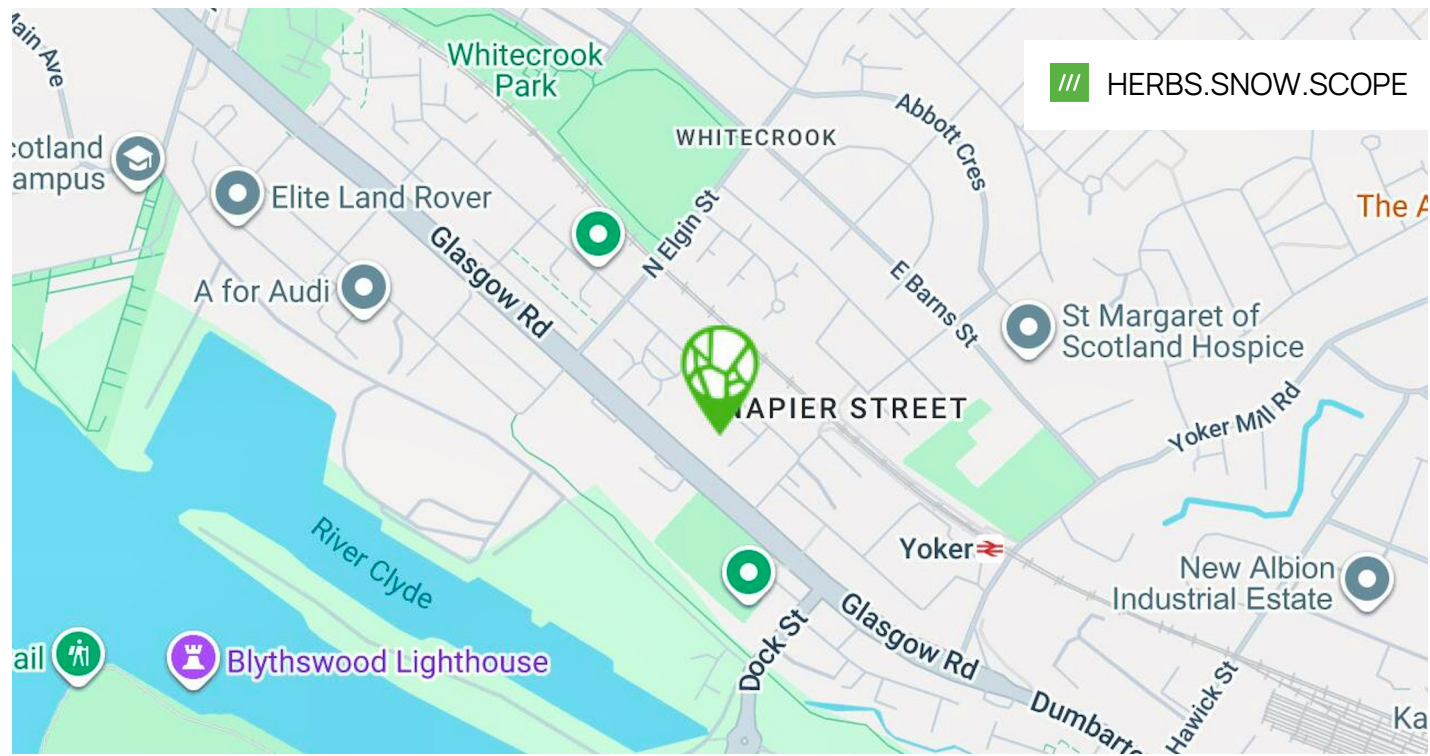
Nearby occupiers include TeamSport Go Karting, Clydebank Bowling Club and Clydebank Football Club.

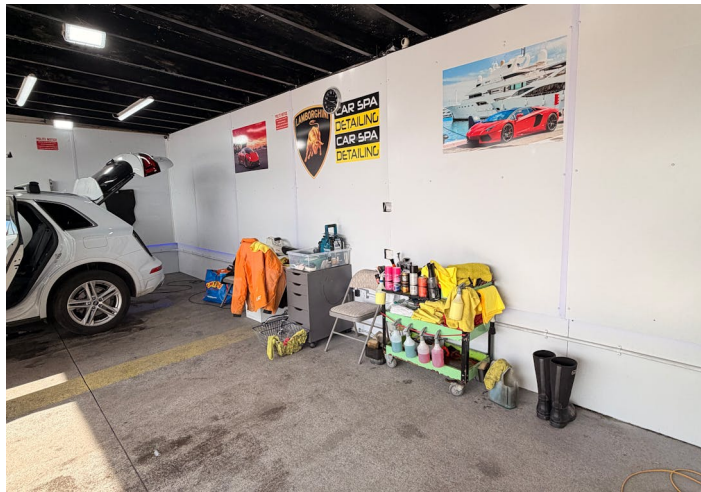
DESCRIPTION

The subjects comprise a rectangular hardstanding site bound by John Knox Street to the south and a railway line to the north. The site extends to circa 652 sq m (7,018 sq ft).

The site is accessed from John Knox Street and has twin covered valet bays, 3 x open valet stations and 10' x 32' portacabin at the rear of the site. The covered valet bays benefit from 2 x multifunction tower 4 in 1 (Air, Vacuum, Screenwash and fragrance) Electrajets forecourt and car valeting machines. The open valet bays benefit from 2 x multifunction tower 7 wash mode buy time jet washes. The portacabin provides a customer waiting area, office, kitchen and WC.

There is the option to extend the site by leasing additional circa 4,000 sq ft site area or containers linked to the site.
