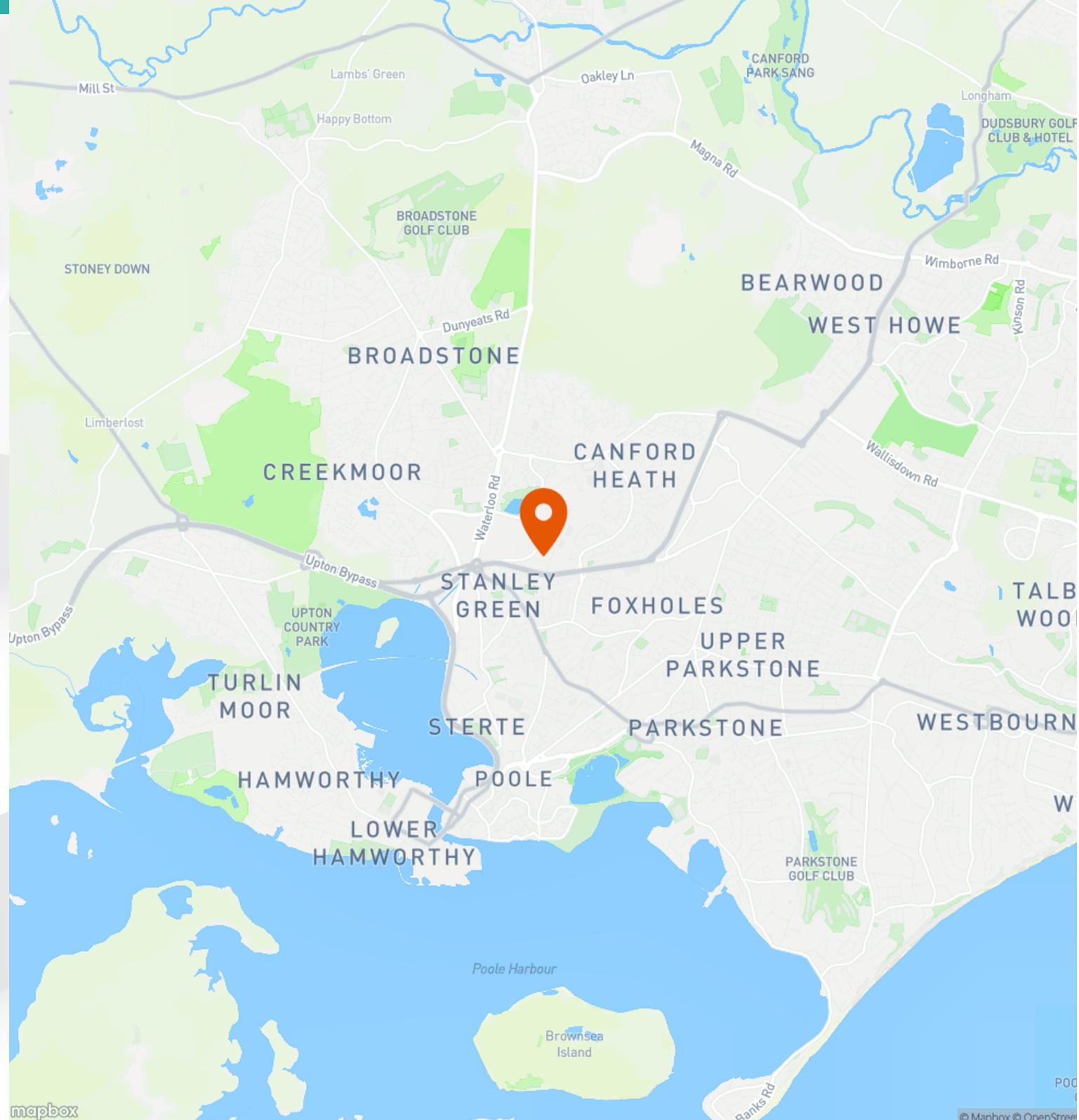

Description

This end of terrace industrial premises is of blockwork inner, brick work outer construction with steel cladding to the upper elevations and the pitched roof. There are windows at ground and first floor levels in the front and side elevations. Internally, there is a ground and first floor office which benefits from carpets, lighting, suspended ceiling and gas central heating. The warehouse has a concrete floor and an approx. 5m internal eaves height. Loading is by way of the roller shutter door which measures approx. 3m W x 3.6m H. There are kitchenette and W.C facilities. 3 phase electricity is available. Externally, there is a tarmacadam forecourt providing car parking for approx. 8 cars when double parked in addition to the loading apron.
