Description

Anchor house is a very well presented office building, providing office accommodation across two floors. The office is available by way of a internal repairing and insuring lease for a term to be agreed. The rent is exclusive of all outgoings.

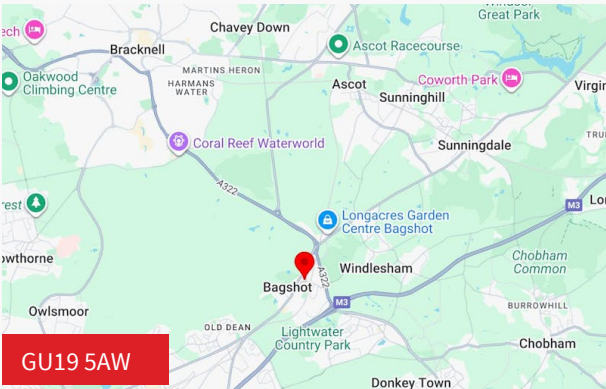
