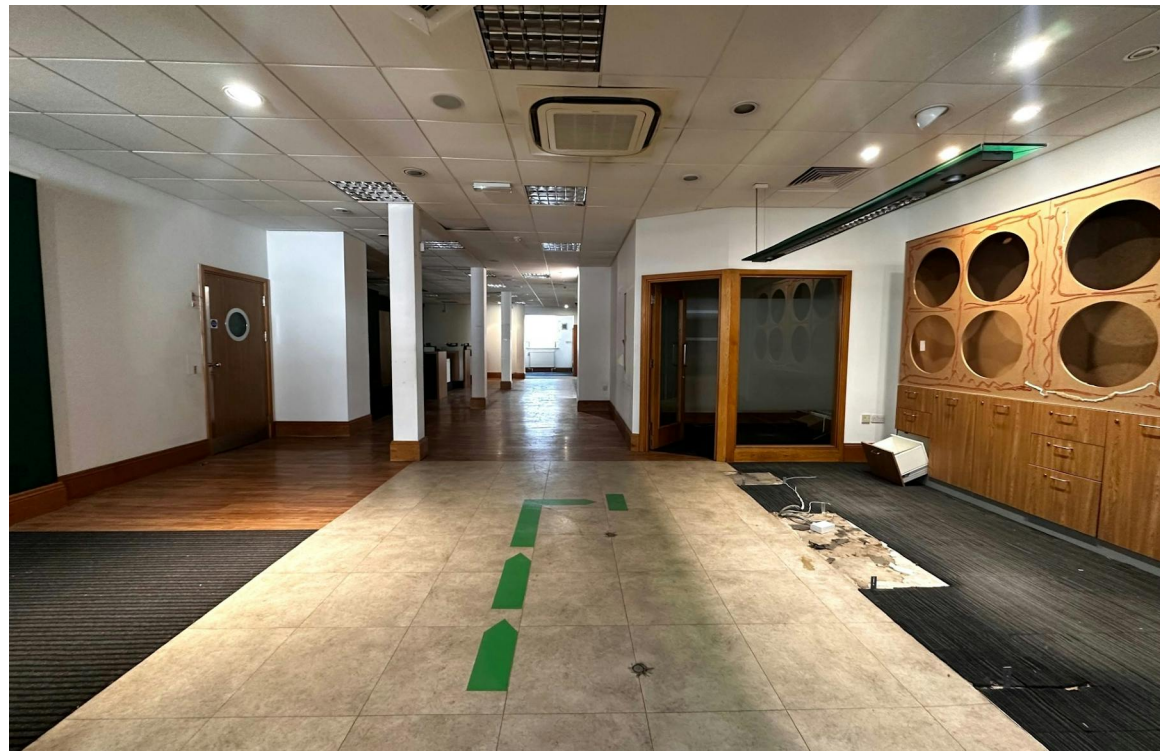
## DESCRIPTION

The property occupies a highly prominent corner position in the heart of Bromsgrove town centre, offering excellent visibility and footfall.

The ground floor comprises a generous open-plan retail space, ideally suited to a variety of retail, service-based or leisure occupiers.

Access is provided via a pedestrian entrance directly off Bromsgrove High Street, with an alternative rear access available from the car park on Windsor Street. This leads through a secure, enclosed courtyard into a welcoming, DDA-compliant entrance.

The layout is highly adaptable and could accommodate a range of uses, with further ancillary accommodation available at basement and/or upper levels, subject to occupational requirements.



## LOCATION

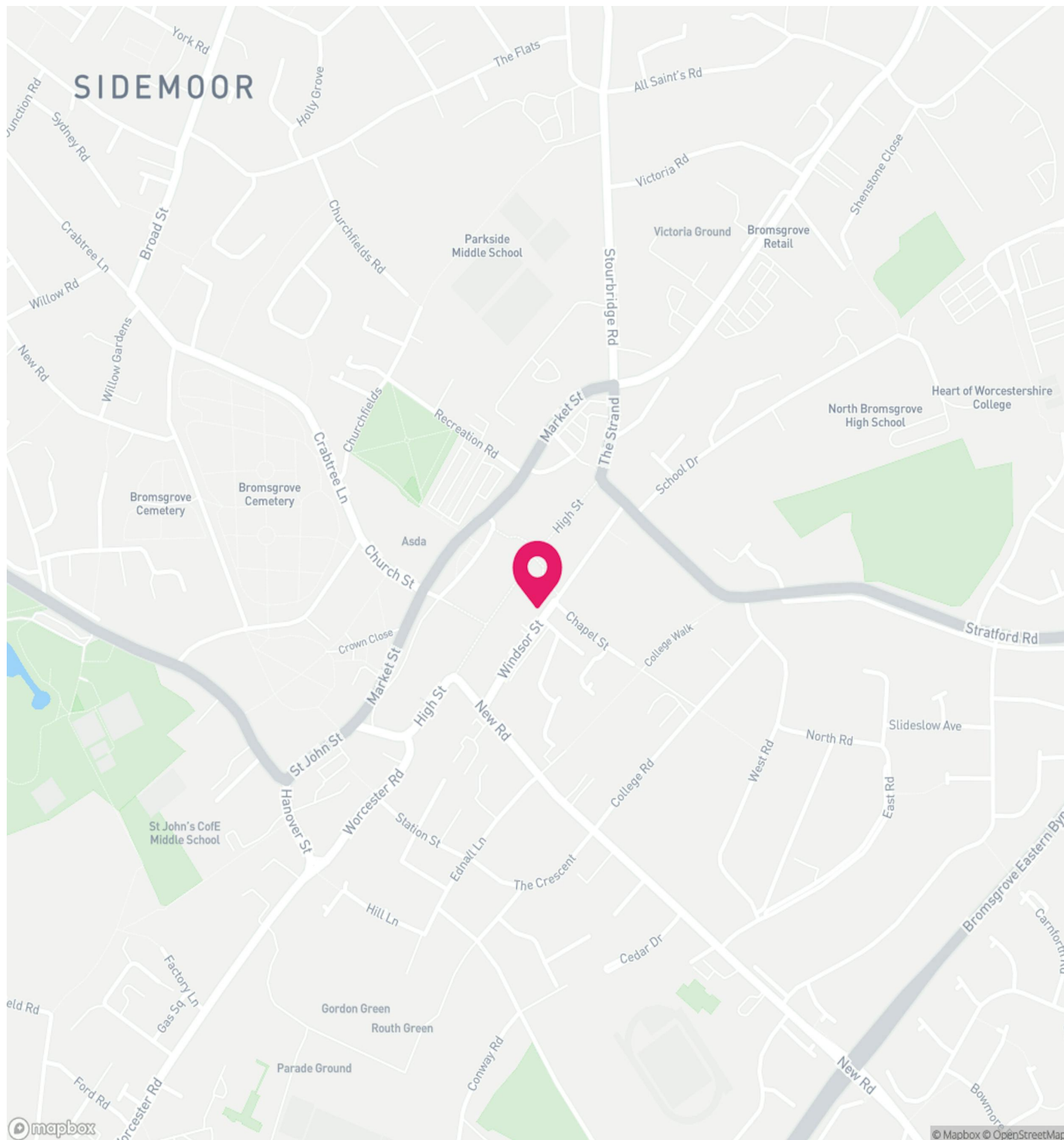
The property is situated on the east side of the High Street next to its junction with Chapel Street with access to Windsor Street which leads onto the main A448 Stratford Road.

Bromsgrove is located some 13 miles south-west of Birmingham, 16 miles north-east of Worcester and is an attractive suburb of the West Midlands.

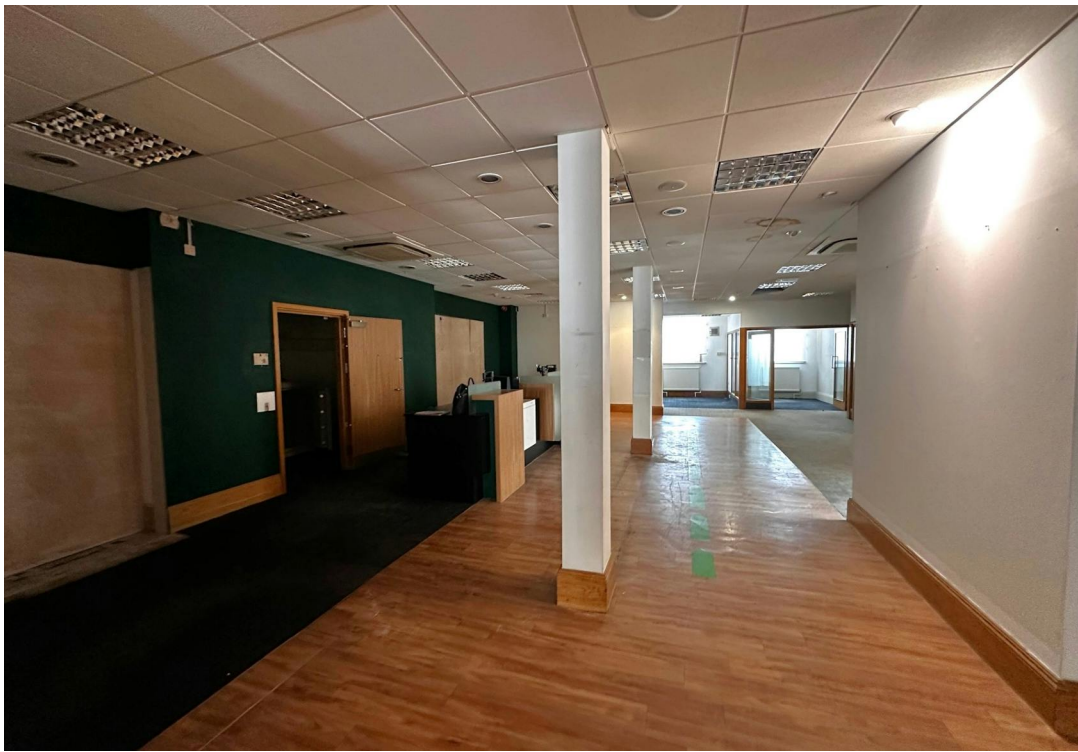
Bromsgrove benefits from good road communications with the M5 immediately to the west and the A38 to the east, both of which provide easy access to Birmingham.

Bromsgrove Rail Station provides regular services to Birmingham New Street, Worcester Foregate Street and Hereford.
