Bristol Business Park is established as one of the premier office locations in North Bristol. Neighbouring occupiers include Babcock, Thales, Boeing, UWE and The Forestry Commission. The Park is located approximately 6.5 miles north of the City Centre and is just 2 miles from Junction 19 of the M4 Motorway, accessed via the M32. The park is adjacent to the University of the West of England, circa 1.5 miles to the MOD procurement facility at Filton and is just over 2 miles from Parkway Mainline Railway Station.

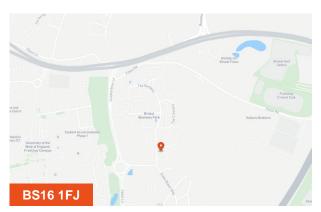
