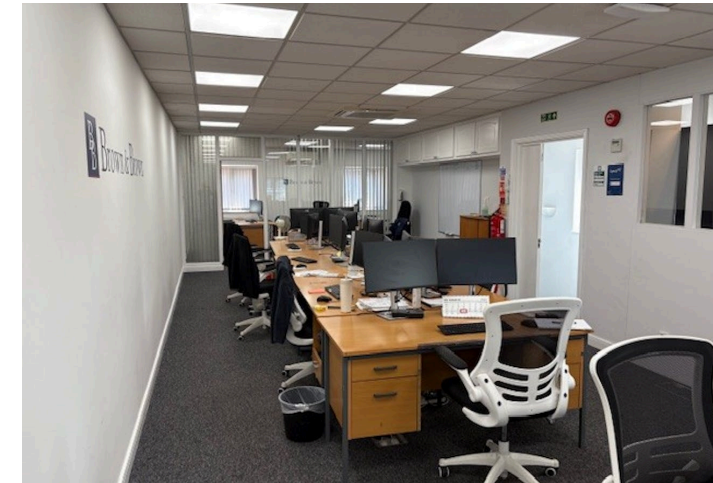

## Description
