LOCATION

Cumbernauld is a town in North Lanarkshire, Scotland. It is the tenth most-populous locality in Scotland and the most populated town in North Lanarkshire, positioned in the centre of Scotland's Central Belt.

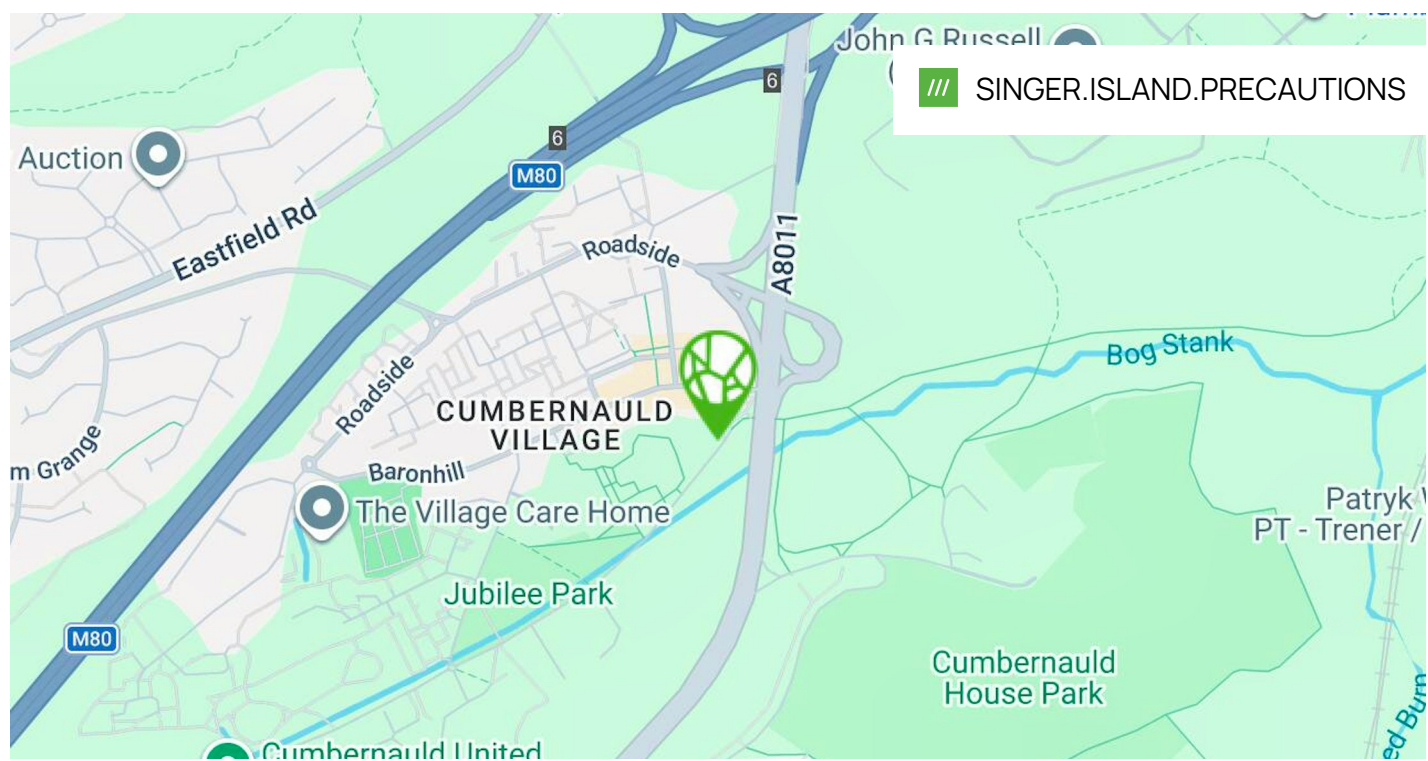
The subjects are located on the south side of Main Street, close to its junction with The Wynd, in The Village. Surrounding properties are of mixed design, vintage and character. Greenfaulds Train Station takes 5 minutes to drive. Nearby occupiers include Village Pharmacy, The Spur and The Village Post Office.

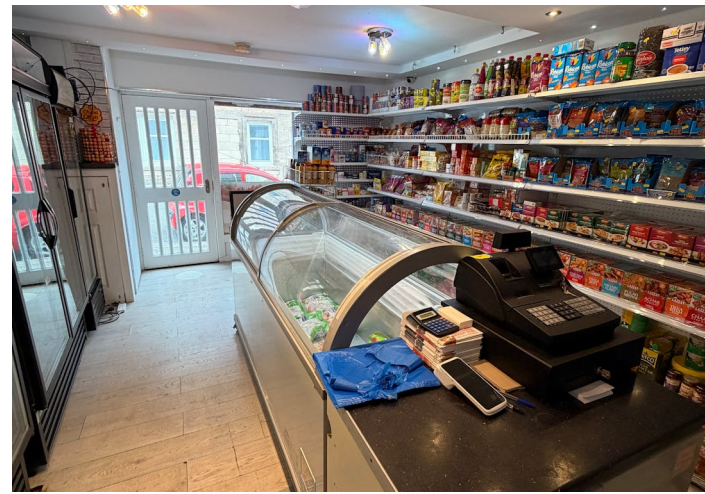
DESCRIPTION

The subjects comprise a ground floor retail unit and a 1 bedroom flat within a 2 storey building of masonry construction which sits under a pitched slate roof.

11 Main Street - The shop has a timber glazed frontage under a non-illuminated fascia board and is accessed via a single pedestrian door which leads into the sales area. The floor is covered in laminate and the walls are of plaster/paint. The plaster/paint ceiling incorporates LED spot lighting. A store, kitchenette and WC are provided to the rear of the shop.

13 Main Street - The flat is accessed from the ground floor where there is an entrance vestibule and stairs to the first floor. On the first floor the accommodation extends to a hall, living room open to kitchen, bedroom and bathroom with WC.
