### Location

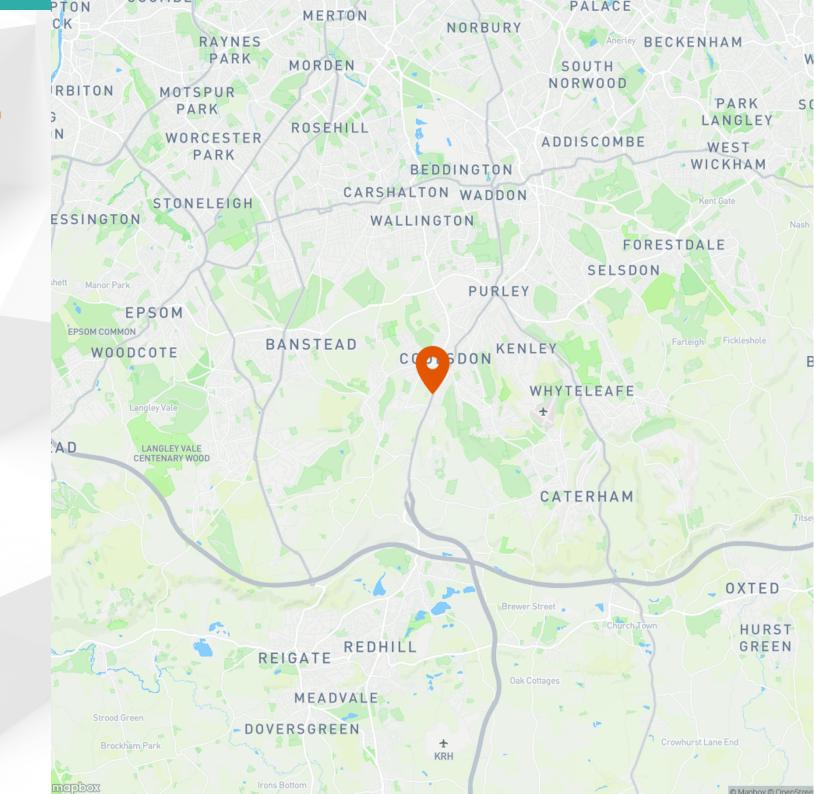

The property occupies a prominent position on Brighton Road (A23), which connects to Junction 7 of the M23 and Junction 8 of the M25, approximately 4 miles to the south.

Central London lies around 14 miles to the north, with Croydon 5.5 miles north and Crawley 15 miles south. Gatwick Airport is easily accessible via the M23.

Coulsdon South train station, located approximately 0.8 miles north of the property, offers direct services to both London Victoria and Gatwick Airport.

#### **Description**

The property comprises of a prominent former Land Rover/BYD car dealership on a site of approximately 1.41 acres.

An excellent 'roadside' site consisting of; main sales showroom building with first floor offices/stores, a detached car workshop with roller shutter door access, garage unit, wash down area, external sales office, and substantial car parking and display areas for approx. 130 cars.

Road frontage onto A23 Brighton Road of 442 ft (135 metres) being highly visible from passing traffic (both ways) and with two unrestricted vehicular access into/from the site.

Planning permission was permitted for demolition of existing buildings and construction of a mixed-use of car showroom and two one-bedroom flats at first floor plus a car parking deck (planning ref19/04276/FUL). Plans and images available.

Potential for future redevelopment (roadside commercial, residential, care or mixed uses) subject to required planning consent.
