Location

27 Sheet Street is located in Windsor town centre, very close to Windsor Castle and the main shopping area as well as The Long Walk. Windsor benefits from two mainline rail stations providing services to London Waterloo and The Elizabeth Line from the Central Station via Slough. The town centre is approximately two miles from Junction 6 of the M4 motorway, with Heathrow Airport (accessible by road or rail) approximately ten miles to the east.

Description

Suite 14 is on the second floor of this well managed multi-occupied office in central Windsor. Light and bright with windows facing Sheet Street and the rear courtyard.
