Location

Corsham is well located on the A4 between Chippenham and Bath. Junction 17 of the M4 is approx. 9 miles away.

Leafield Industrial Estate forms one of the principal employment areas in Corsham. Ingoldmells Court forms a cul de sac of industrial warehouse units accessed via Edinburgh Way. Unit 4 holds a mid terrace location.

Description

Unit 4 Ingoldmells comprises a two storey business unit with a flexible range of accommodation in it.

At ground floor, there is a open plan store/workshop area with access via a commercial vehicle roller door. Internal eaves height is approximately 2.5m.

At first floor the accommodation is fitted out to a high standard comprising 4 separate office rooms with a kitchen and WC facilities. The offices benefit from suspended ceilings, LED lighting and are double glazed and have comfort cooling units.

Outside the unit benefits from two 2 allocated car parking spaces.

Please note, the adjoining Unit 5 is also available and can be combined with unit 4. Unit 5 provides up to a further 3,121 sq ft of workshop/storage accommodation.
