### Description

Industrial / warehouse for sale - detached unit of self-contained site.

#### Location

The property is strategically located at the southern side of Milford Haven Waterway at Pembroke Dock. The town can be accessed via the A477 trunk road from the A48, which extends from junction 49 of the M4 motorway. Pembroke dock railway station has direct national rail services to Swansea and London Paddington. In addition, Pembroke Dock has a ferry service to and from Rosslare in Southern Ireland. The Port of Milford Haven is the busiest UK energy port and has recently been awarded Freeport status as part of the Celtic Freeport bid, linked to the proposed Floating Offshore Wind project planned for the Celtic Sea. The unit is situated on the eastern side of Ferry Lane, which links with the A477 at its northern end. To the west of the property the predominant land use on the opposite side of Ferry Lane is residential. The property immediately adjoins a development of two modern industrial units along its southern boundary, known as Ferry Lane Business Park.

Includes a basement access via 2 level full height roller shutter doors and a minimum eaves height of 4.8 metres.

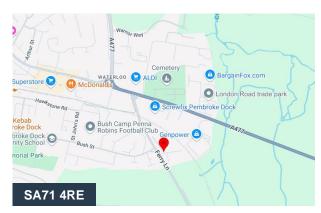
