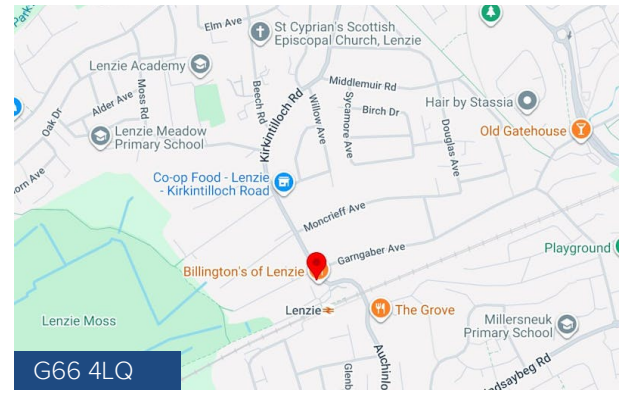

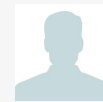

Lenzie is an affluent suburb, situated approximately 7.9 miles north east of Glasgow City Centre, with excellent transport links via rail and road via the M80 motorway. 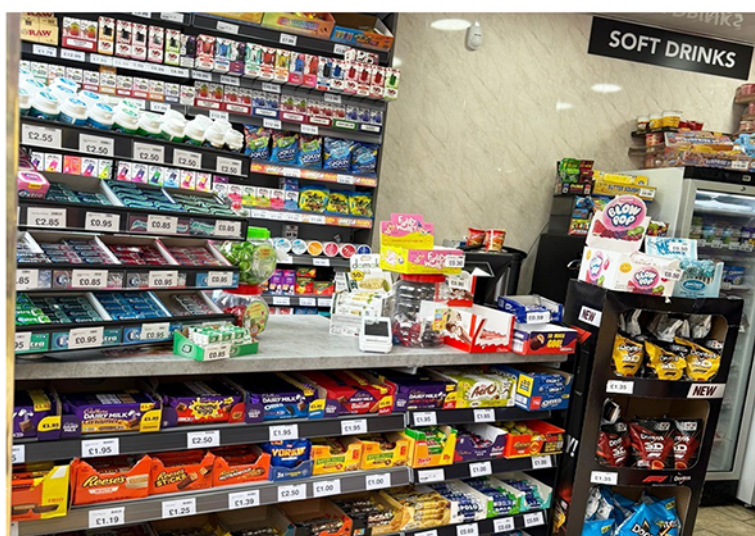
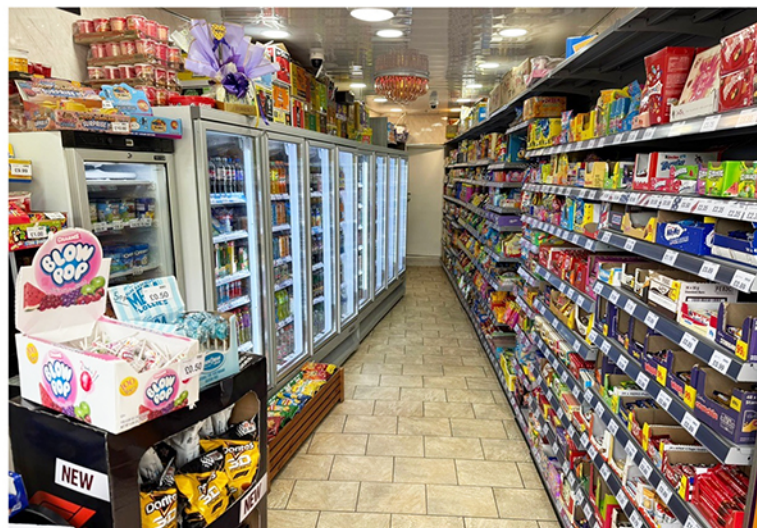
The property comprises a mid terrace, ground floor commercial unit set within a larger 2 storey sandstone development surmounted by a pitched roof overlaid in slate.
