

Location

Enterprise Trading Estate is located on the border of Southall, Greenford and Hanwell in Zone 4 West London. Forming part of the wider and well established Great Western Industrial Park the estate is well connected by road with the A4020 Uxbridge Road located a short distance to the north, providing access to the A40 via A4127 Greenford Road at Greenford roundabout. The A4020 Uxbridge Road also provides access via Southall to the A312 and M4 J3 and Southall Cross Rail Elizabeth Line Station is located just 2.3 miles to the West.
