Description

Town Gate House provides a prominent ground floor commercial unit in the heart of Woking town centre, with an external frontage facing Jubilee Square. The premises benefit from Class E use, suitable for a range of occupiers including retail, restaurant, office or gym uses.

Location

The property is located on Jubilee Square, immediately adjacent to Victoria Place Shopping Centre and within Woking’s principal retail and leisure pitch. Nearby occupiers include Nova Cinema, GAIL’s, Søstrene Grene, Primark, Next, M&S and H&M, with additional occupiers in the vicinity including Mokka Bistro, Costa Coffee, Pret a Manger, and JD.

Woking Station is approximately a 5-minute walk, providing direct services to London Waterloo with average journey times of 25-minutes. Heathrow is approximately 12 miles (c. 19 km) to the north and Gatwick approximately 32 miles (c. 51 km) to the south east.

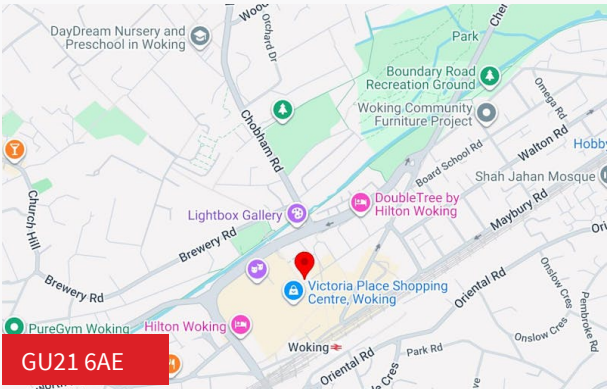
