## Location

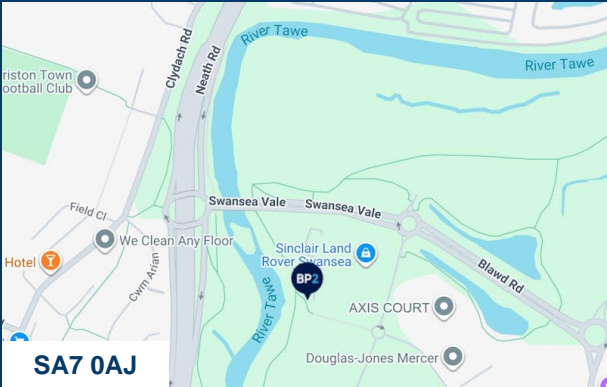
