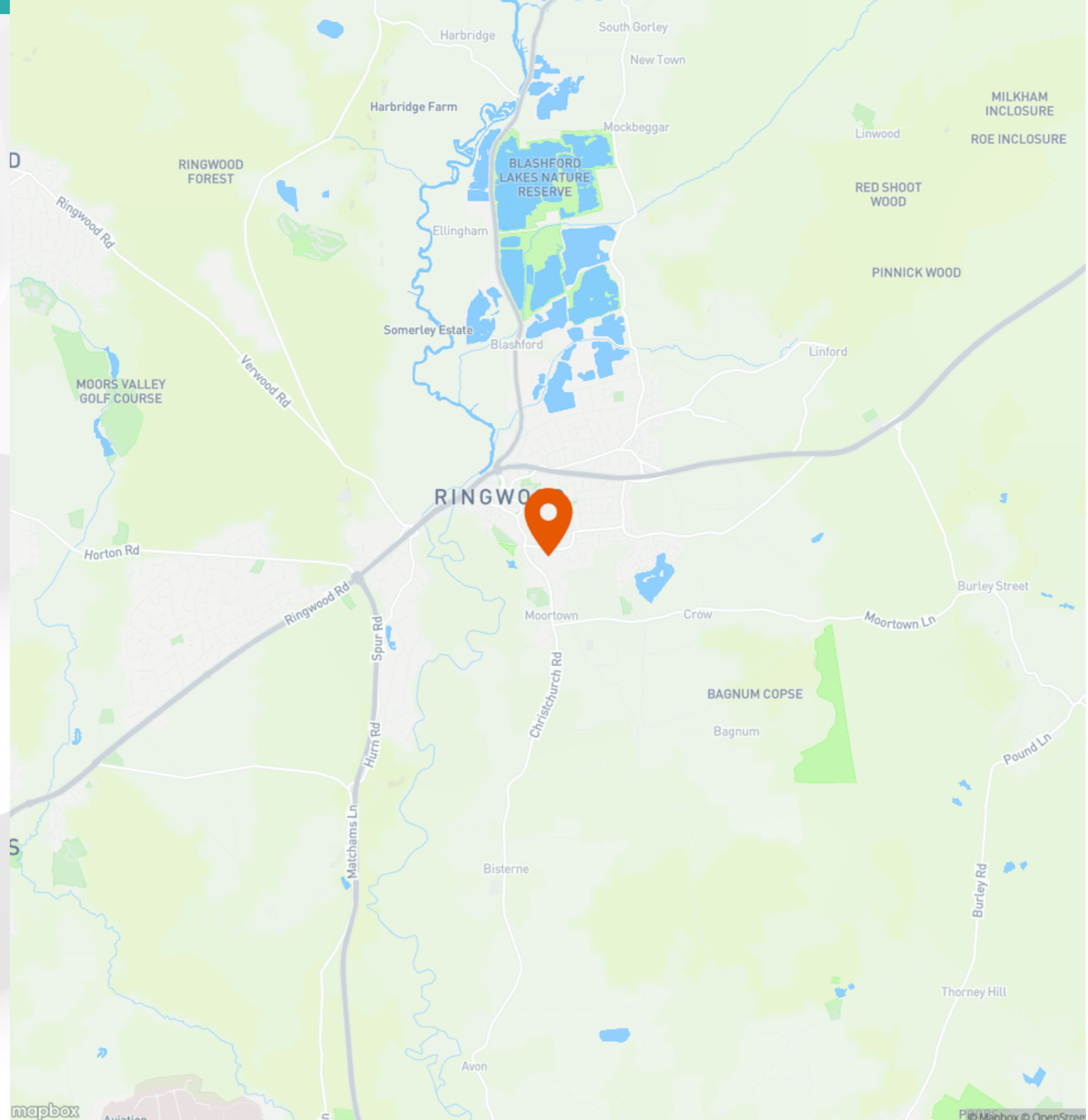


# Location

Austin Park was developed in 2016 comprising of offices and industrial properties and forms part of the wider business park which is accessed off Christchurch Road. Occupiers on the business park include Lidl, Anytime Fitness and Premier Inn. The business park is approximately 0.8 miles distant from Ringwood town centre which provides a number of retail and restaurant facilities. The A31 is approximately 1 mile distant from the premises.

## Description

This ground floor, self-contained office is fitted out to a high-quality specification and the accommodation is available fully fitted and furnished. The office is arranged as a main open plan working area with a large kitchen/break out space and collaborative working area. There is glass partitioning providing a separate office and a board room. There is air conditioning, LED lighting, suspended ceiling and opening windows. There are male, female and accessible W/C facilities. Externally, there are 4 allocated car parking spaces which can fit 8 cars when double parked. There are EV charging points.

## Property Measurement Standard

All floor areas are approximate and measured to Net Internal Area in accordance with the RICS Property Measurement (2nd edition) incorporating RICS Code of Measuring Practice (6th edition).
