## DESCRIPTION

The property comprises a single storey warehouse of steel truss construction with brick infill to full height. The unit has recently been refurbished, including a new pitched roof incorporating translucent roof lights.

The unit provides open plan warehouse accommodation, benefitting from painted concrete flooring, emulsion coated walls, high bay lighting, WC facility and three-phase power supply. The unit has a minimum eaves height of 3.4m rising to 5.6m at the apex.

Loading access is provided by roller shutter leading directly into the yard area.

Ample car parking is available within the estate.




## LOCATION

The property is situated on Plume Street Industrial Estate off Plume Street in the Aston area of Birmingham and can be accessed from either Long Acre or Holborn Hill.

The area is adjacent to the (A47) Heartlands Parkway providing dual carriageway link between Birmingham City Centre and the nearby motorway network.

Birmingham City Centre is located approximately 2 miles south west. The immediate area is well served by public transport with regular bus services and being only a short distance from Aston train station.
