Glen Court is situated on Canada Road, accessible through Oyster Lane in Byfleet. Oyster Lane serves as a connecting route between Addlestone and Byfleet. The Byfleet & New Haw Railway Station is within walking proximity.

To the east, approximately 3 miles away, lies the A3, which can be reached via the A245 Byfleet Road. The M25 is accessible from Junctions 10 and 11, located about 4 miles and 3 miles away respectively.

In close proximity is Brooklands, offering a range of amenities including a 24-hour Tesco Extra Superstore, Marks and Spencer Supermarket, Mercedes Benz, and the Brooklands Hotel.
