DESCRIPTION

The property comprises part of a medical centre and is constructed from traditional brick construction beneath a pitched tiled roof, arranged over ground and first floors.

Internally, the accommodation provides a welcoming ground floor reception area with a series of consulting rooms, together with ancillary storage and amenity space. A DDA-compliant WC is also provided.

The first floor is accessed via both staircase and lift, and currently offers an openplan office area suitable for a variety of uses. This space could easily be partitioned to create further consulting rooms or private offices, depending on occupier requirements.

The property benefits from double-glazed windows, LED lighting, emulsion-coated walls, perimeter power and data.

Externally, the premises enjoy a forecourt to the front together with a large car park to the rear, providing generous on-site parking.







LOCATION

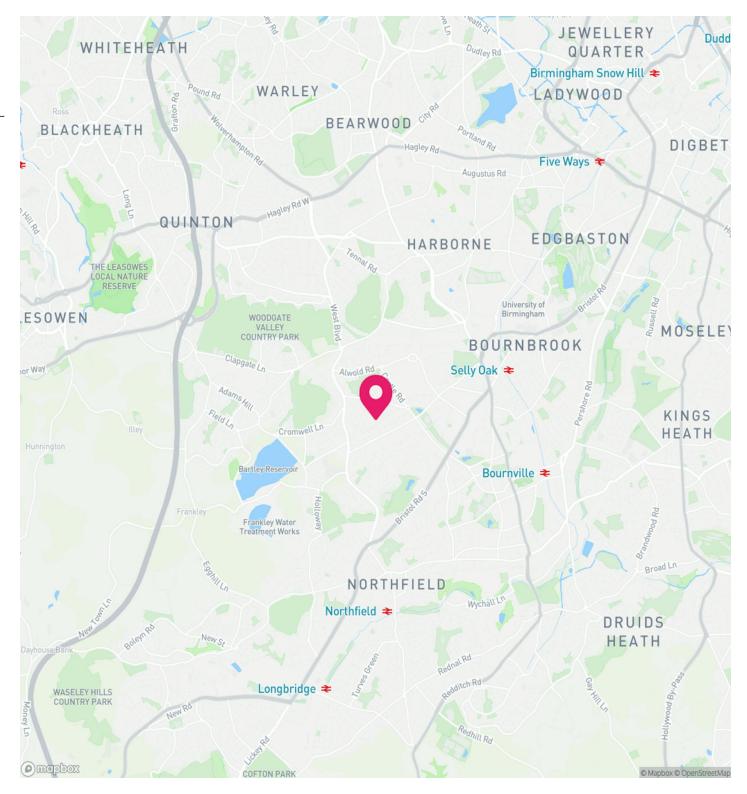
The property is located in Weoley Castle, a popular residential suburb some 4 miles south west of Birmingham City Centre.

The property has a prominent frontage onto Castle Square, a busy roundabout with retail parades on three sides with occupiers including Savers, Card Factory, Heron Foods, Greggs and Betfred.

Public transport links are excellent, with regular bus services running along Weoley Castle Road and nearby routes connecting directly to the city centre, Selly Oak, and Harborne.

The Selly Oak train station is around 1.5 miles away, offering frequent services to Birmingham New Street and beyond.

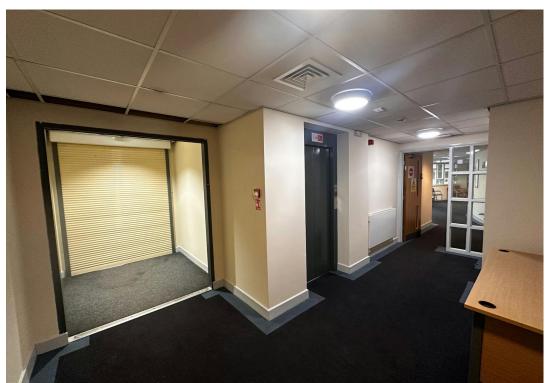
