Description

The property comprises a modern, mid-terrace industrial / warehouse unit of steel portal frame construction, with profile metal clad elevations under a pitched, double skin metal clad roof. Unit B is specified with 7m eaves height, three phase power supply, electrically operated up and over loading door, and overhead gas fired heating to the warehouse. There are ancillary offices running the length of the property with a staffroom, kitchenette, toilets and shower. Immediately above there is a mezzanine providing 553 sq ft of additional storage space. To the front of the building there is allocated parking, and shared loading yard.

Location

The property is located on Berrington Way, which forms part of the Wade Road industrial area of Basingstoke. Neighbouring occupiers include Exertis Hammer, Euro Accessories Limited, Thermo-Fisher Scientific and GTK UK Limited. Specifically it is within Prisma Park, which is a modern development comprising a mix of offices and light industrial premises.

Access to Basingstoke's ring road system is about half a mile to the west and in turn provides direct links to Junction 6 of the M3 motorway about 1 mile to the south and the A33 trunk road leading to Junction 11 of the M4 motorway at Reading. Rail connections are also good with a mainline 45-minute rail link to London, Waterloo from the town's railway station, approximately 1 mile to the southwest.
