## LOCATION

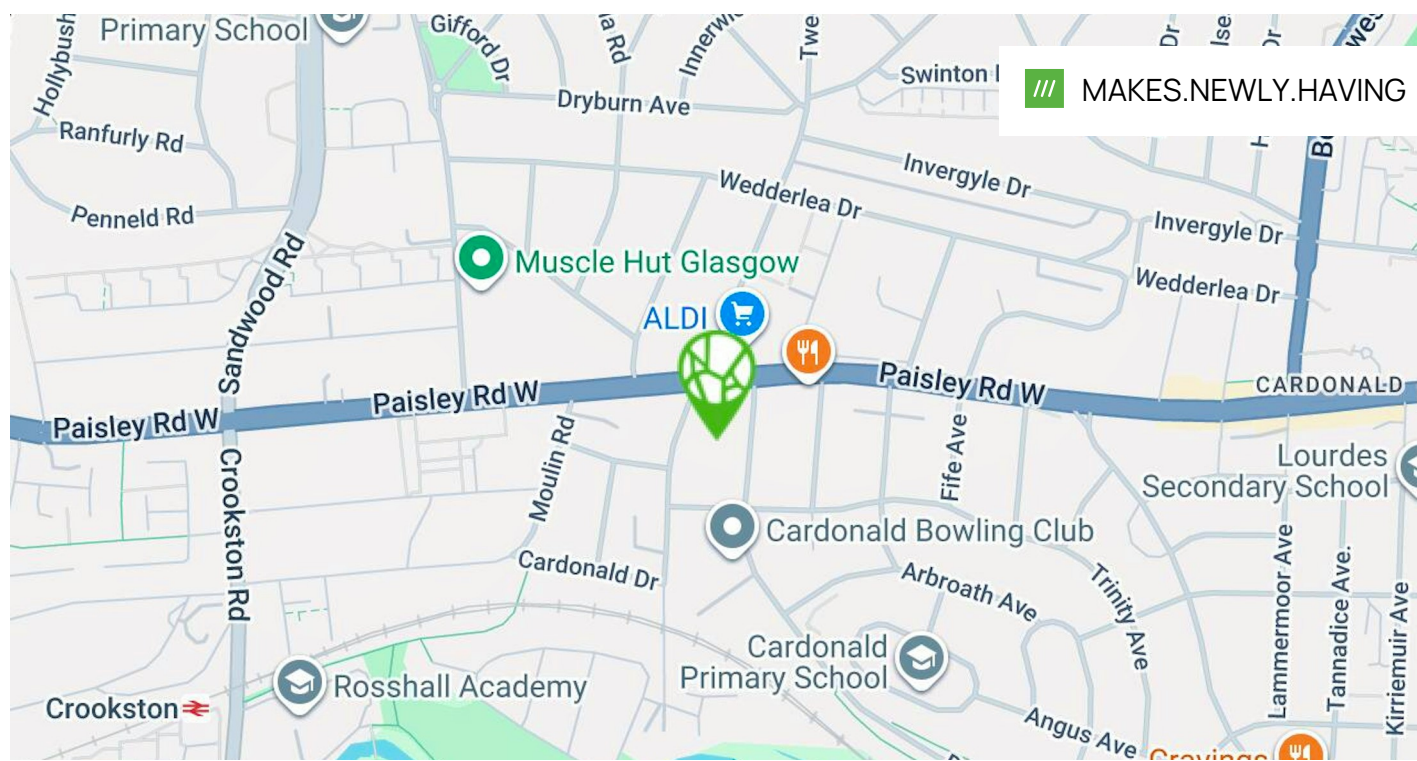
The property is located between Penilee and Mosspark around 5 miles west of Glasgow city centre. The subject property is situated on the south side of Paisley Road West, close to its junction with Cardonald Place Road. The property enjoys excellent public transport connections, with regular bus services passing along Paisley Road West. Crookston train station takes less than 5 minutes to reach by car. Nearby occupiers include Aldi, Boots Pharmacy, Yayas, Lucky B's Hot Chicken.

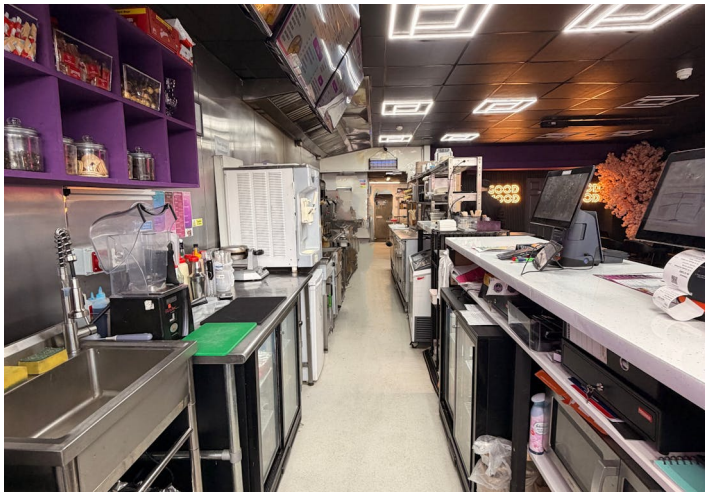
## DESCRIPTION

The subjects comprise a mid terraced Class 3 hot food restaurant and takeaway within a single storey retail parade which sits under a flat roof.

The double fronted property is accessed via a single flush pedestrian door which leads into the customer waiting area. Beyond this there are a mix of tables, chairs and booths with a capacity of circa 30 covers. The space is fitted out to a high standard in corporate branding. The commercial kitchen is, as expected, fitted out to a professional standard with extract ventilation and a range of stainless steel sink units, utility basins and fitments.

A comprehensive range of floor and wall mounted style units are installed with appropriate worktops. The floor is of commercial laminate, walls covered with branding / splashbacks and the suspended grid ceiling incorporates square LED lighting. There is a walk-in chill room and ancillary accommodation to the rear. Free car parking is provided to the front of the property.

The premises provide a new tenant with a first class 'walk in' licensed premises.

The lease is available by way of assignation, for the residual term of the lease, which expires in August 2035. The current rent is £30,000 per annum with fixed uplifts to £32,500 per annum in August 2028 and £35,000 pa in August 2030. There is a tenant break option in August 2030.

## RATEABLE VALUE

According to the Scottish Assessors Association, the subjects have a Rateable Value of £21,750.

The occupier may be eligible for Hospitality Relief of up to 40% of the Rates charge, subject to status.
