The property is a purpose-built former church building. The building is grade Il listed as are the external railings. The construction comprises of masonry walls with facing stonework and bathstone quoins to the window openings. There are mainly single glazed windows with some stained glass. The land has no visible graves.

#### Location

The property occupies a corner plot on Priory Street and The Avenue, Carmarthen and is approximately 1 mile from the A40.

Carmarthen is an historic market town located within the centre of the county of Carmarthenshire, approximately 30 miles to the west of Swansea and 70 miles to thewest of Cardiff.
