Description

The property comprises an end of terrace industrial/warehouse unit constructed of traditional steel portal frame with brick elevations. The property has been comprehensively refurbished. Offices are provided at first floor level and benefit from new UPVC windows, AC and LED lighting.

A self contained yard area is provided to the side of the property with additional loading doors having been added to access the industrial/warehouse area.

The property is situated in Brook Trading Estate off Deadbrook Lane accessed via North Lane. North Lane provides easy access to the A331 Blackwater Valley Relief Road serving both Junction 4 of the M3 motorway to the north and the A31 Hogs Back and in turn A3 to the south.


