Location

Hatch House is situated just outside of Datchet village centre and is approached by a private estate road. The scheme has direct access to Junction 5 of the M4, onto Heathrow at Junction 4 and into London. Datchet is on the Waterloo main trainline with a regular 37 trains a day service.


