This property represents an excellent opportunity for businesses requiring secure and flexible external storage space in a strategic and well-connected setting.



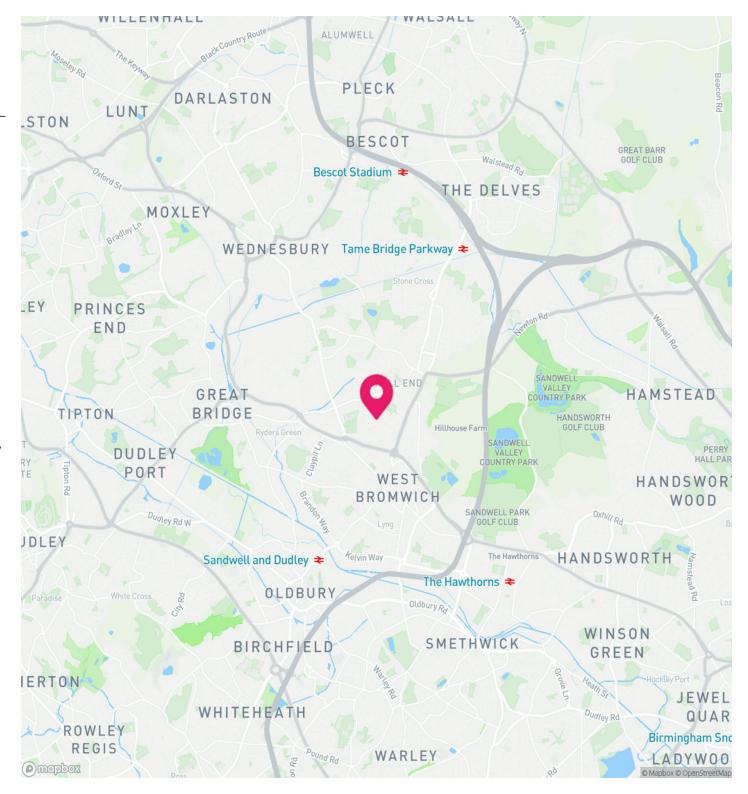




LOCATION

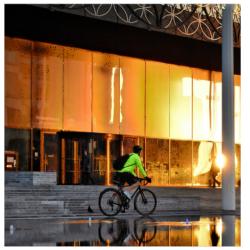
