A single storey unit constructed of steel frame with blockwork infill under a double pitched roof with a level painted concrete floor.

Access is via loading & personnel doors.

Internally, the unit is currently configured as an open plan workshop/store with fitted kitchen, offices, WCs with shower. Additionally, a useful mezzanine floor is included providing light storage & office space.

Externally, allocated parking is available and additional free on street parking is available close-by.

This unit is best suited to a tenant requiring light storage or clean industrial trades. Heavier industrial processes and motortrade will not be considered.

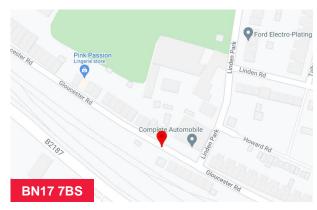
