Hackney Downs 0.1 Miles



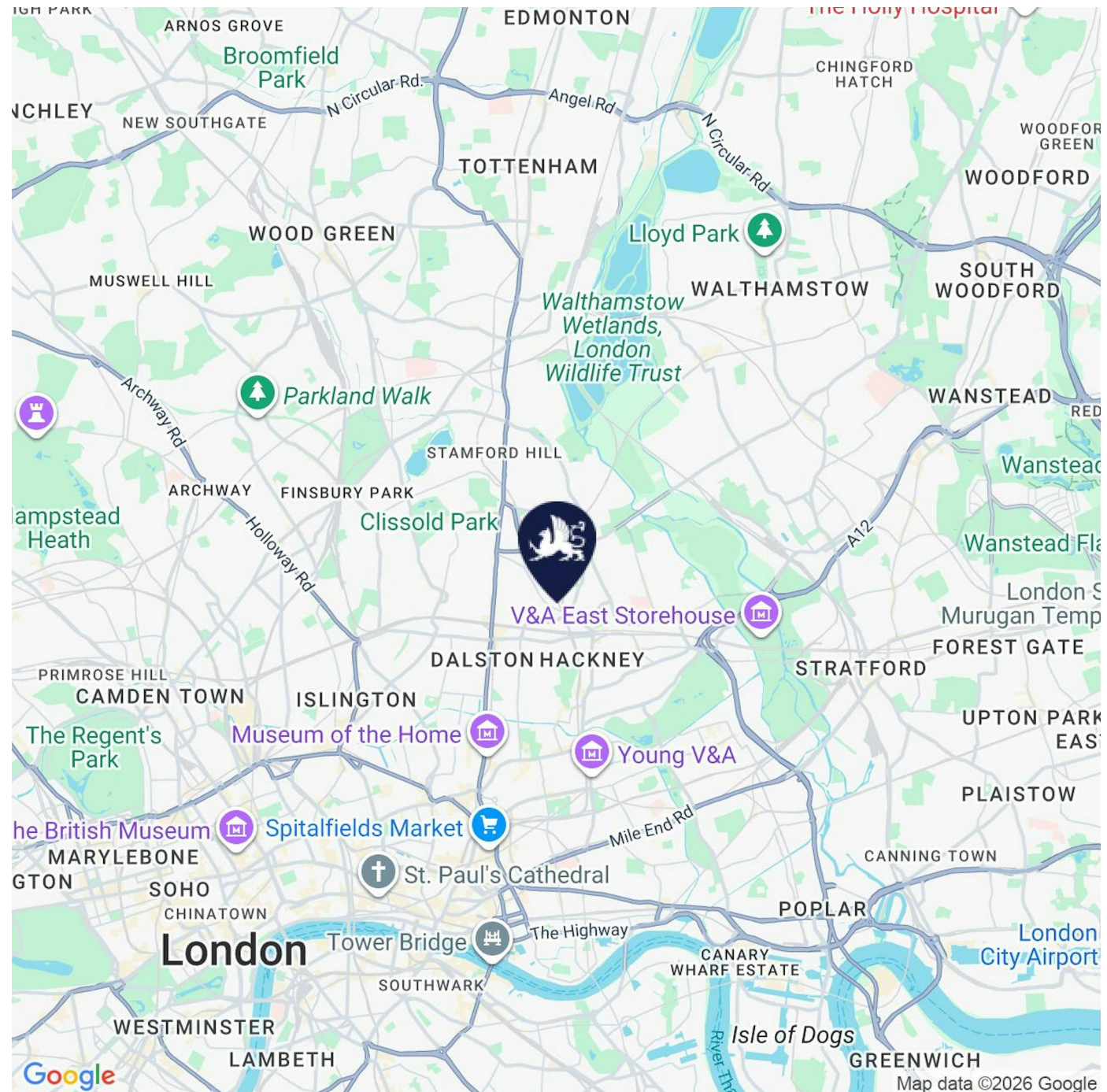
Hackney Central 0.4 Miles
