Description

The unit is arranged over the ground and basement. The ground floor is a large open rectangular shape with no columns and has space for storage at the rear. The basement historically had a kitchen, male and female WCs and a large open space for events and dining. Both floors have adequate floor to ceiling heights and would suit a variety of occupiers. The unit has been stripped out and is currently in shell condition. Temporary lighting has been fitted and there is an existing extract system in place.

Location

The property is located on the south side of Holborn between Chancery Lane and Holborn Circus adjacent to the A40, a main London trunk road, and in close proximity to National Rail Stations/a number of bus stops. It is a two minute walk from Chancery Lane Underground, and within close walking distance from Holborn Underground Station and Farringdon.


