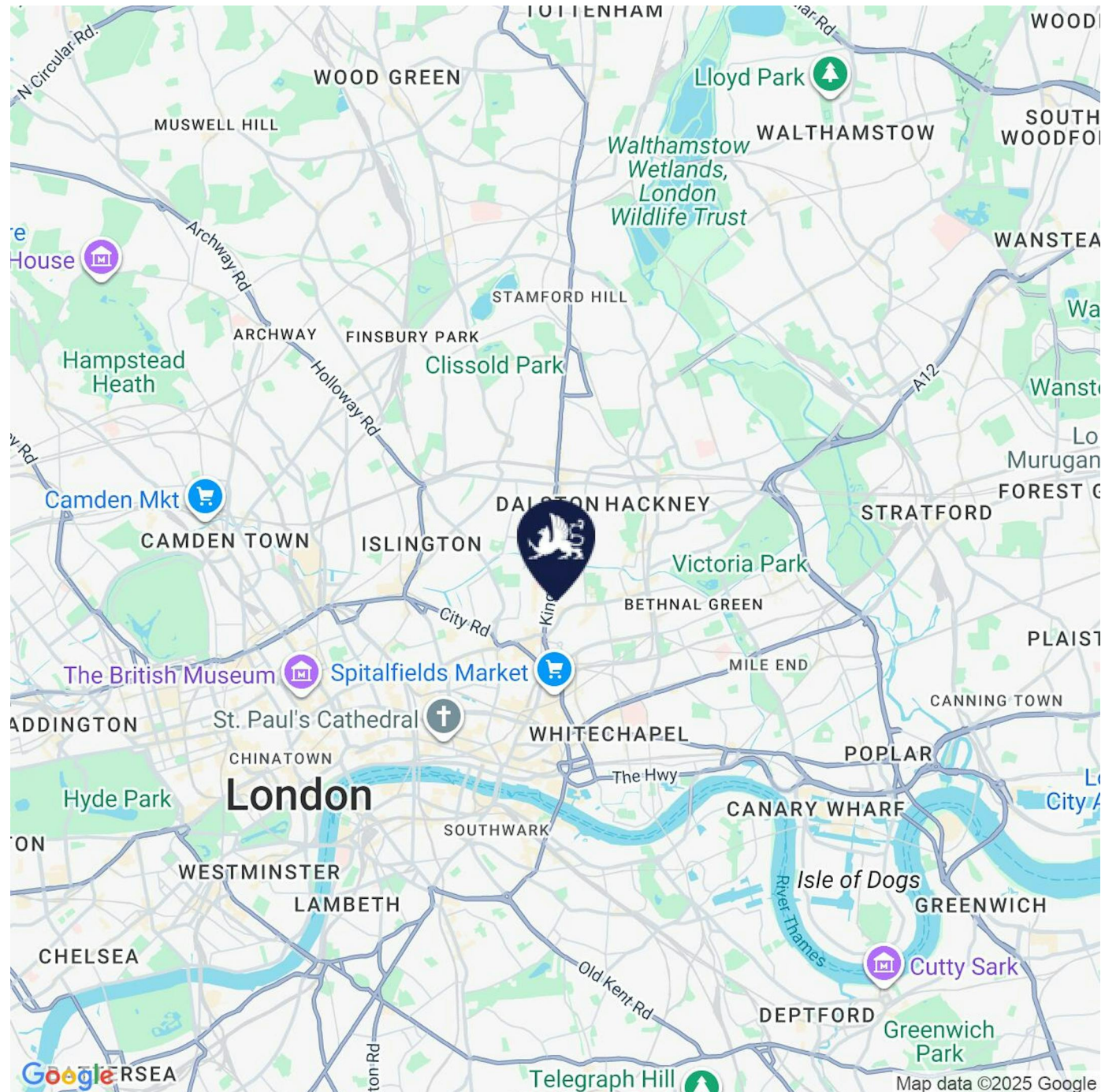
Haggerston 0.5 Miles
