Description

Location

The property is located in a popular residential area which is within walking distance of the local shops and post office at Lochee High Street. Transport links are on your doorstep offering frequent bus services to Dundee's City Centre and Ninewells Hospital. The property is within walking distance of the local primary and secondary schools.

Dundee is Scotland's fourth largest city with an estimated population of 145,000 and a catchment population in the region of 515,000. The city is the regional centre for commerce, retailing and employment within the Tayside region and is located on the east coast of Scotland with 90% of the country's population within 90 minutes' drive time.

Site Area

The site area extends to 0.11 acres or thereby.

Planning

The site currently has planning permission for the erection of a new office and parking area. The proposed accommodation provided for 6 spacious offices along with large storage areas, breakroom and accessible toilet facilities, extending to approximately 103.5 sq m (1,114 sq ft) or thereby.

It is proposed that there will 3 parking spaces to the north of the building.


