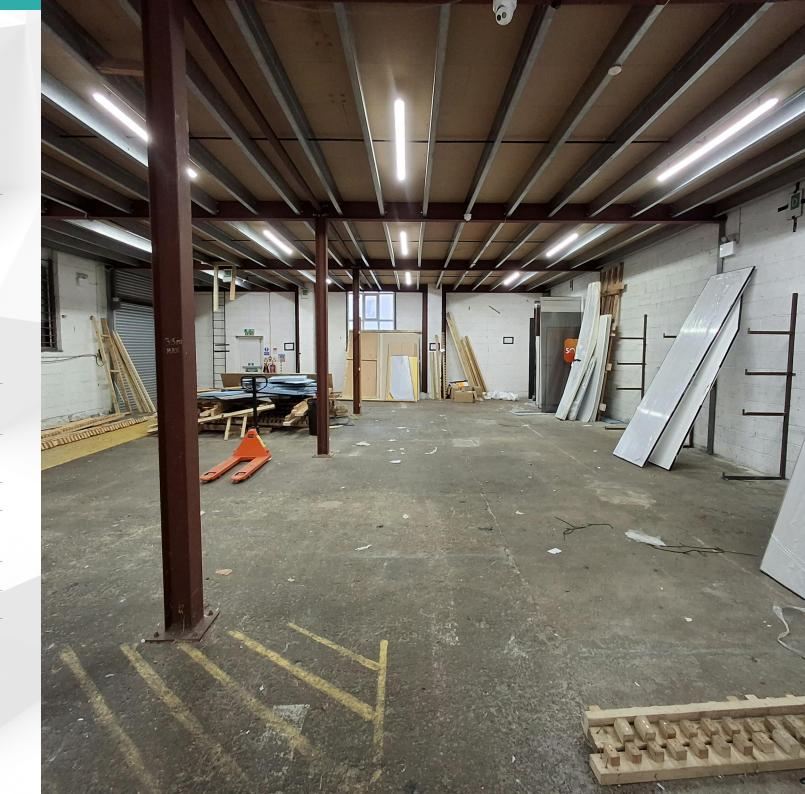

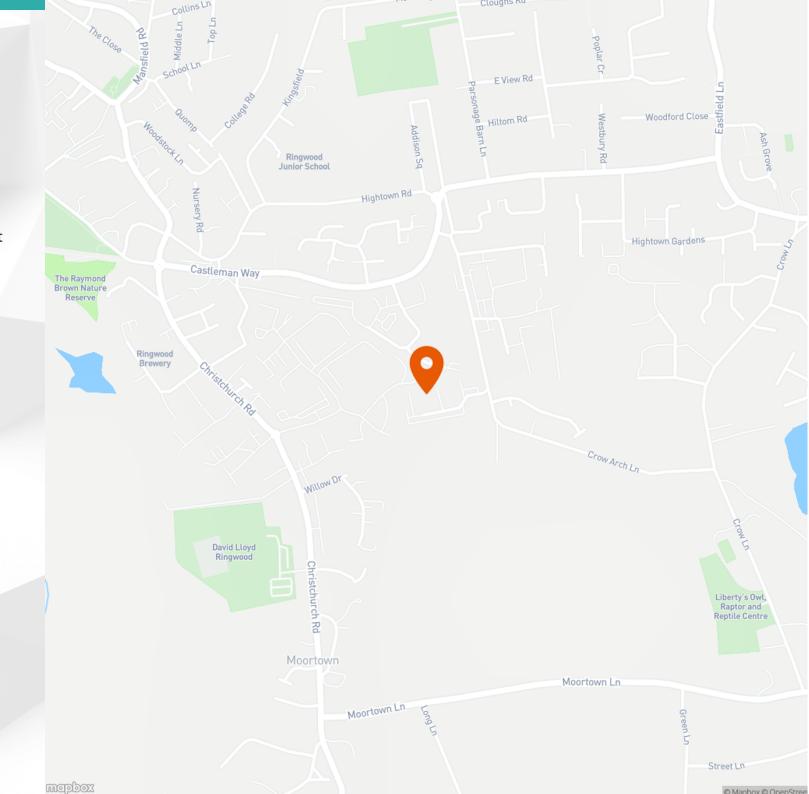


Location



Unit 8 Crow Arch Lane Industrial Estate, Ringwood, BH24 1PD

The unit is located on Crow Arch Lane which is accessed from Castleman Way. It is approximately 1 mile distant from Ringwood Town Centre which benefits from a variety of retail and restaurant facilities. Access to the A31 is approx. 1 mile distant from the premises, which provides direct links to the M27/M3 motorway networks.





Further Details

Description

Unit 8 is a mid terrace industrial/warehouse premises of steel portal frame construction with a pitched roof incorporating daylight panels and concrete floor. The unit benefits from a 1st and 2nd floor mezzanine and the height below is 3.5m. The internal eaves height is approx. 7.7m and the roller shutter door measures approx. 3.5m W H.Internally,there is a separate personnel door, ground and first floor offices,M&F WC, kitchenette / breakout area, lighting and has 3 phase electricity.

The 1st floor mezzanine offers a mix of offices and storage and the 2nd floor offers storage.

Externally, there is a concrete loading apron and 12 allocated car parking spaces.

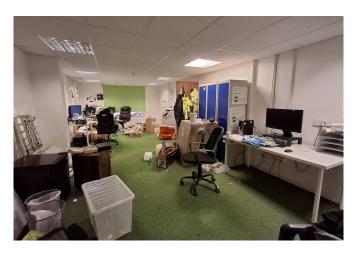
