Description

The premises form a ground floor lock up shop, part of a modern development running alongside Datchet Station and level crossing fronting the High Street. It benefits from good window displays and reverse frontage onto Manor House Lane. Fitted to an excellent standard the shop has a modern showroom / retail sales area suspended ceiling with recessed / feature lighting and air conditioning. The rear of the premises comprises a treatment room, stores area, modern galley kitchen and w/c.

Location

5 High Street Datchet is next to the railway station and level crossing in the centre of this pretty Thames side village close to Windsor. Adjoining occupiers in the parade include Coral Bookmakers, a barbers and Nibbles sandwich and coffee shop. Occupiers opposite in this busy village centre include a local Londis. 20 minutes free parking is provided in the adjoining station car park, with on street parking in addition. Being by the level crossing the parade benefits from strong passing traffic.

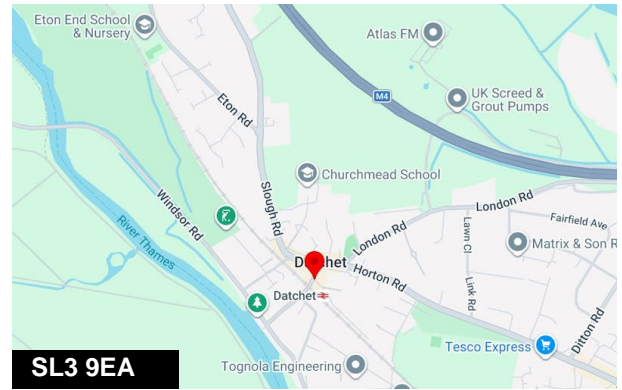

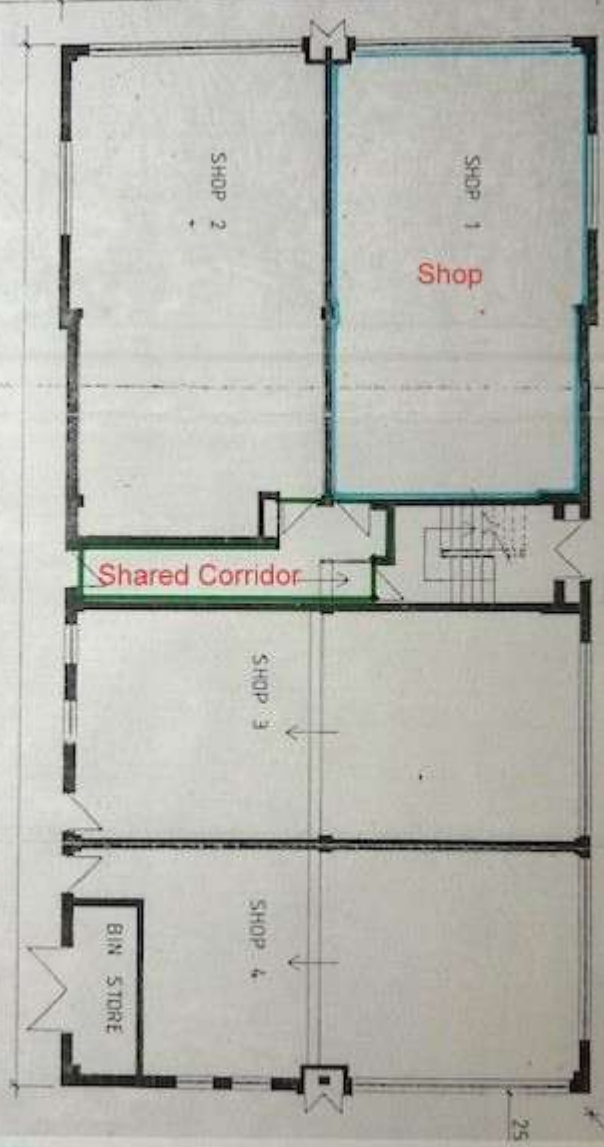
