LOCATION

Blantyre is located on the River Clyde and sits approximately 9 miles south-east of Glasgow, 37 miles south-west of Edinburgh and can be accessed from Junction 5 of the M74 motorway.

The property is located on the north side of Calder Street, close to its junction with Victoria Street. Calderside Academy is immediately opposite. Blantyre Train Station takes less than a 3 minutes drive to reach.

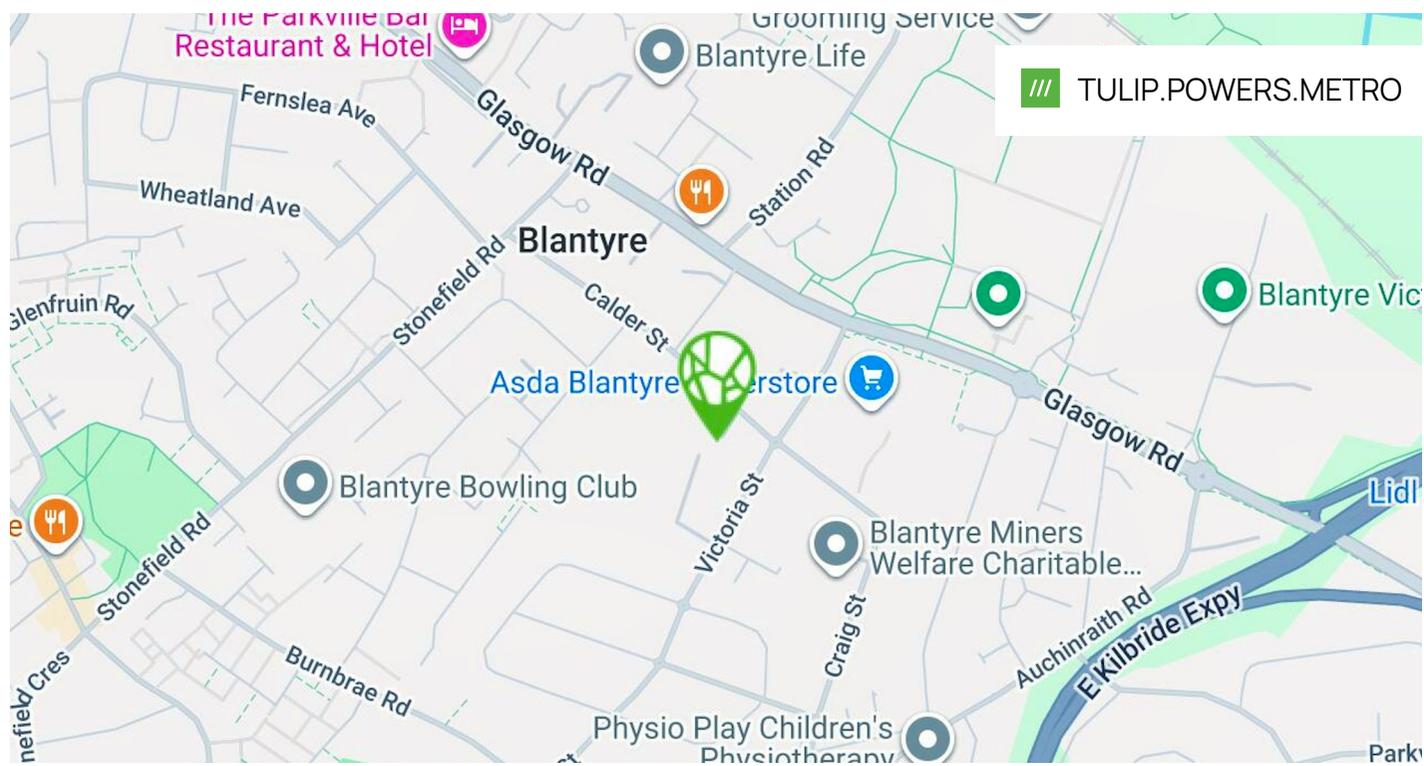
Nearby occupiers include Blantyre Asda Superstore, Calderside Medical Practice and Auchinraith Primary School.

DESCRIPTION

The subjects comprise a secure yard fronting the main road and a basement industrial unit to the rear which was previously used as a gym. The unit is accessed via a stairwell which leads into the main hall. Off the main hall there are offices, storage space, kitchenette and welfare facilities.

The floor is covered in carpet, masonry walls painted and artificial lighting is provided via fluorescent strip lighting. The unit benefits from a secure yard which can be used for private parking / external storage.

There is free on street parking at the front of the property.
