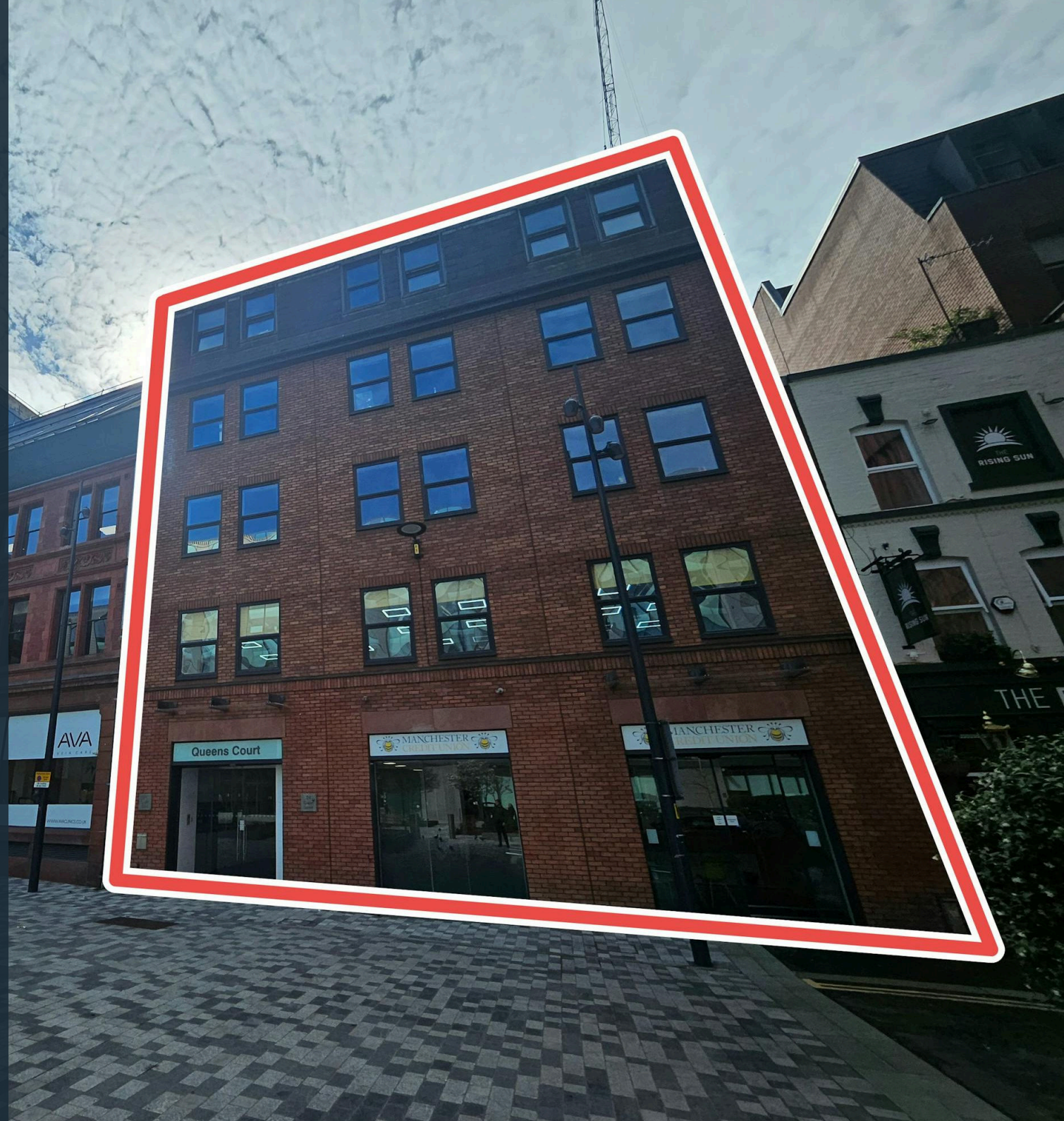

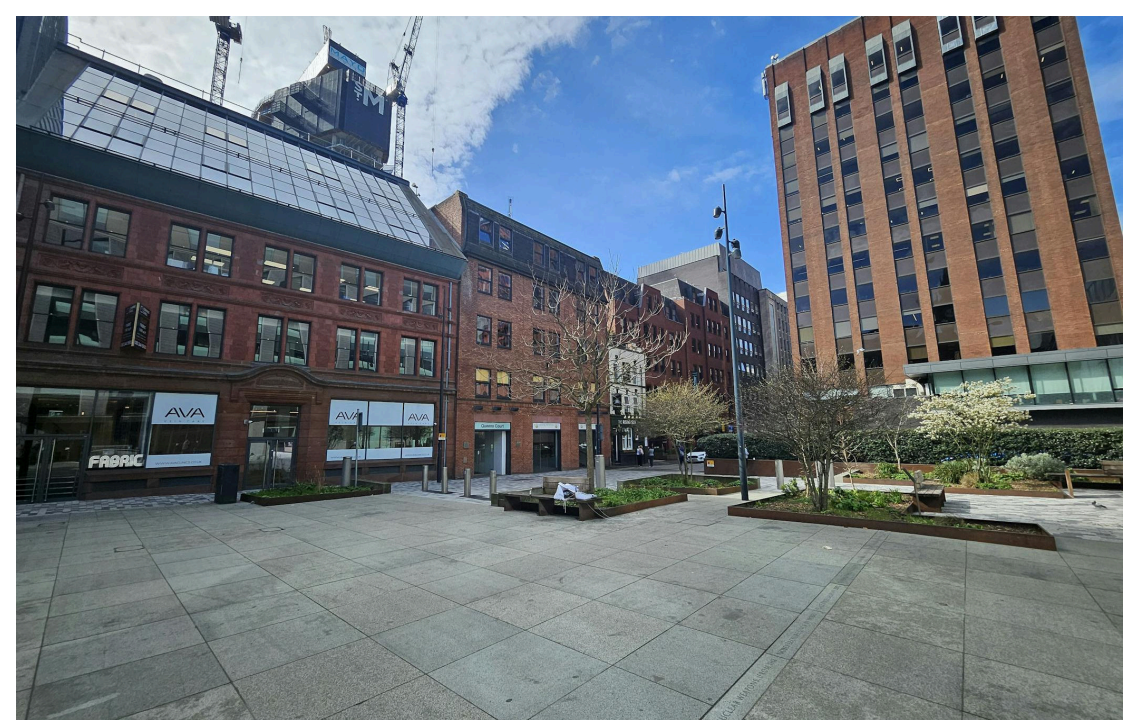

Location

Queens Court is located on Queen Street and fronts onto Lincoln Square, the main pedestrian route linking Deansgate and Spinningfields, through to Albert Square and the traditional office core of Manchester city centre.

The location benefits from excellent access to Manchester's retail core with well known retailers such as Emporio Armani, Ted Baker, DKNY and Mulberry all within a short walk of the premises. In addition, the area is well served by an abundance of hotels, restaurants and bars.

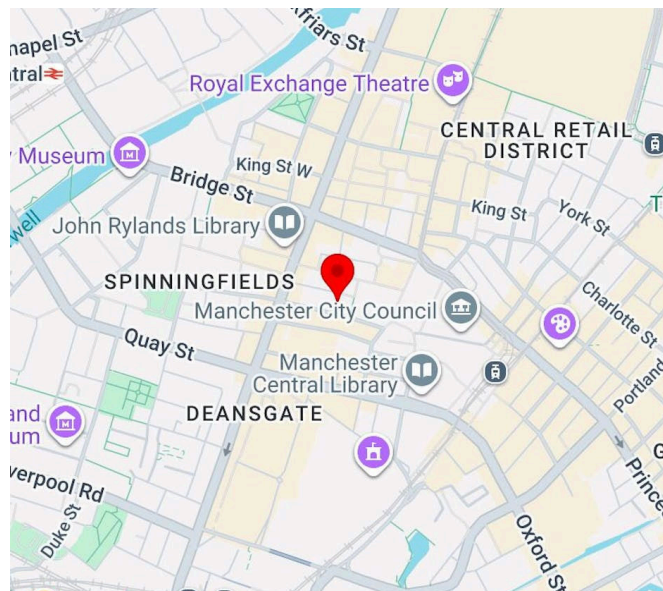
