Location

Fleet is a thriving market town in north-east Hampshire, around 38 miles south-west of London. It benefits from excellent transport links, with the M3 (Junction 4a) a short drive away and regular rail services to London Waterloo in approximately 40–50 minutes.

The property is well positioned in the town centre, surrounded by a strong mix of national and independent retailers. Nearby occupiers include McDonald's, M&S Food, Sainsbury's, KFC, Boots, Costa, Gail's and Starbucks.

There are three public car parks within walking distance, the nearest located directly behind Sainsbury's, ensuring convenient access for customers and staff.
