LOCATION

The premises are situated on the popular Ventura Place Industrial Estate, which has access from Factory Road at Upton Industrial Estate.

Upton Industrial Estate benefits from good access to the A35 Upton Bypass Dual Carriageway, which provides excellent road links within the Poole/Bournemouth conurbation and with other main centres.

The property is situated approx. 3 miles to the north west of Poole Town Centre and with easy access to the Port of Poole via the A350 Blandford Road.

DESCRIPTION

The premises comprise an end of terrace industrial unit of steel portal frame construction with mainly clad elevations and with insulated roof covering incorporating daylight panels.

The premises have a Gross Internal Area of approx 218.79 sq m (2,355 sq ft) which comprises an industrial/warehouse area with office and two WCs.
