DESCRIPTION

The property comprises a modern office building situated within an attractive courtyard style development just off the much sought after St Pauls Square.

The property is arranged over three floors with the ground floor providing a reception area with WC facilities. The first floor offers predominantly open plan office accommodation finished to a high standard and benefitting from suspended ceilings, LED lighting, double glazing, perimeter power and data, air-conditioning, and a partitioned meeting room.

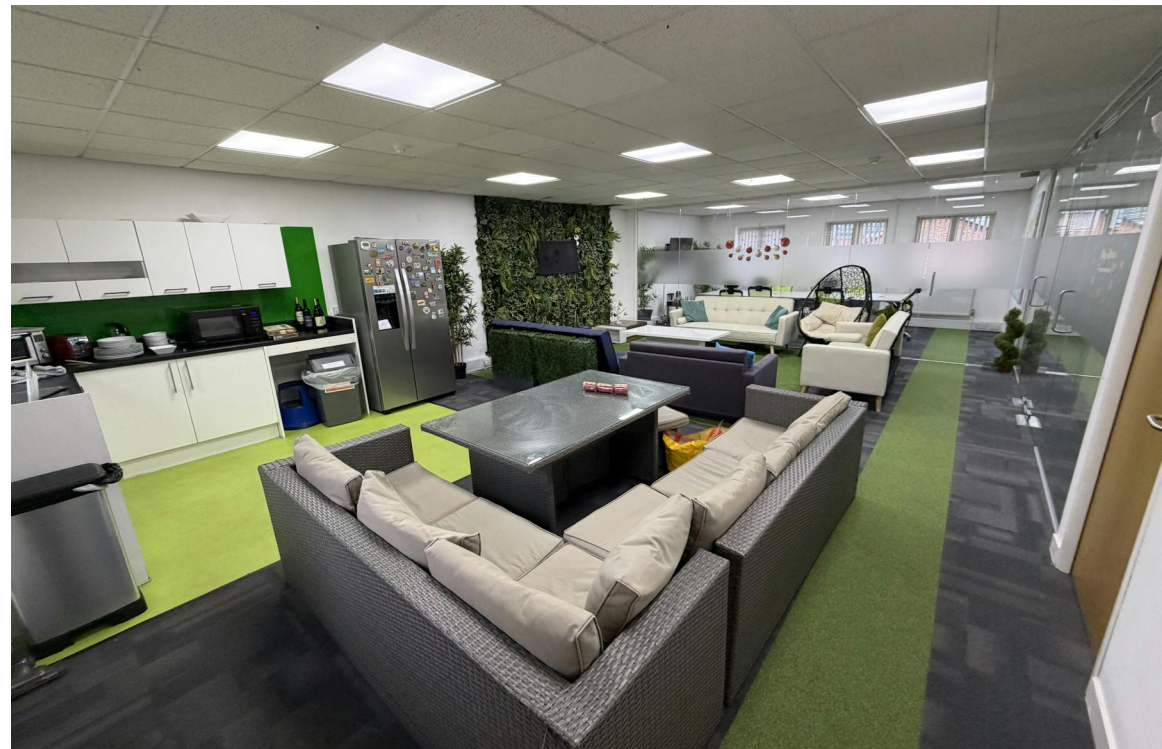
The second floor is of a broadly similar specification, however, also incorporates a large open-plan kitchen and breakout area together with a selection of full height glazed meeting rooms as well as a secure storage/ server room.

WC facilities are provided to each floor which would allow the property to be split into self contained suites if required.

The building has been extensively refurbished throughout and is presented to an excellent standard, allowing an occupier to move in immediately with minimal fit out required.

The property also benefits from central heating and three allocated car parking spaces, secured behind an electronically operated roller shutter.

There is also the option to acquire office furniture, desks, etc if required.

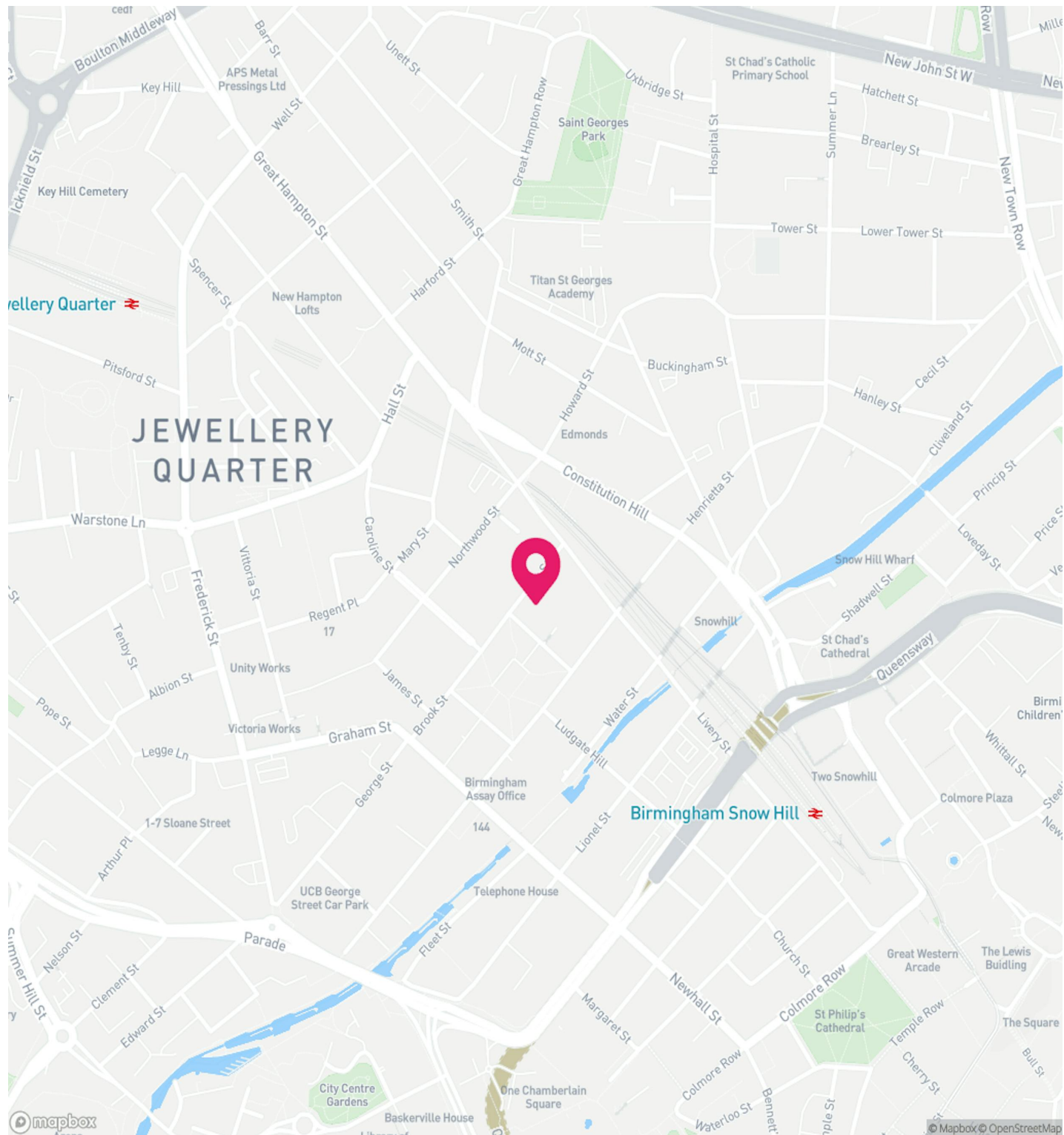


LOCATION

Church Court occupies a prominent position fronting Cox Street, adjacent to the highly regarded St Paul's Square and within comfortable walking distance of Birmingham City Centre.

The property benefits from excellent connectivity, with swift access to the inner ring road and the A38(M) Aston Expressway, located less than one mile away, providing convenient routes across the city and beyond.

The surrounding area is exceptionally well served by public transport. Regular bus services operate nearby, while St Paul's and Jewellery Quarter metro and train stations are both within walking distance. Birmingham Snow Hill and New Street railway stations are also easily accessible, offering comprehensive regional and national rail connections.



THE JEWELLERY QUARTER

The Jewellery Quarter is one of Birmingham's city centre business hotspots.

The Jewellery Quarter is easily accessible with excellent transport links, including Birmingham Snow Hill Station.

This area is a lively hub with a wide selection of bars, restaurants, cafes, and shops to explore. Popular spots include:

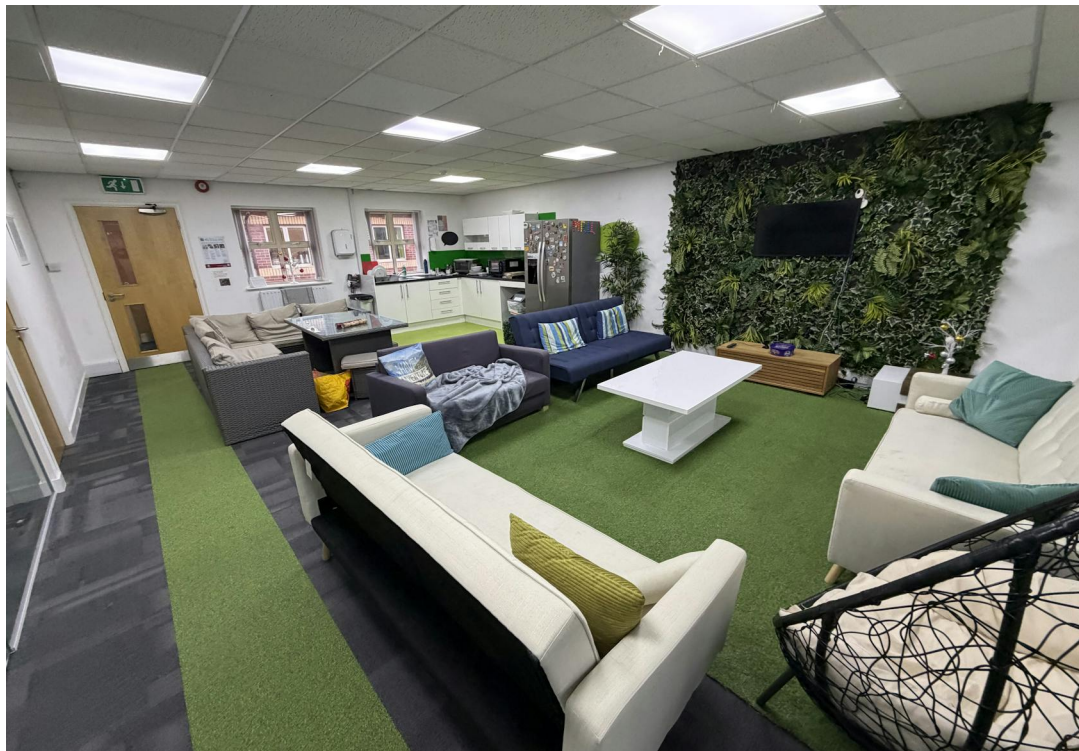
