

## Description

The yard comprises of 0.86 acres (37,486 sq ft) and is laid with crushed and rolled Type 2 aggregate with the site boundary comprising of palisade fencing. There are shared welfare facilities on site but the plot also benefits from its own 3 phase electricity, water and foul waste for tenants to install their own facilities. The current planning use is B8 storage and distribution. The plot can be split with a minimum size of 10,000 sq ft available.

## Location

The unit is located on Theydon Business Park off Hobbs Cross Road, Theydon Garnon. The site is easily accessible via road, located adjacent to Junction 6 of the M11 and Junction 27 of the M25. Theydon Bois Station is a 5 minute drive from the site.

## Terms

The yard is available to let on a new fully repairing and insuring lease for a term of years to be agreed. Rent on letting of parts will be apportioned accordingly.
