

Description

196B Southwark Park Road is a self-contained unit offered across 848 square foot, split between the ground floor and ancillary basement accommodation.

The unit provides flexible open plan space with good ceiling height. The space is well suited to a wide range of Class E activities, including retail, offices/professional services, fitness/studio use (STP), or similar occupiers.

The space benefits from a single glazed frontage with an open plan layout and is offered on a new lease with terms to be agreed, providing an opportunity for an incoming occupier to secure a presence in central Bermondsey/Southwark.




Location

Located in Bermondsey on Southwark Park Road in SE16, a well-established South East London location.

The location benefits from regular local footfall, proximity to Southwark Park, and strong residential density. It is easily accessible to surrounding areas including Bermondsey, Canada Water, Surrey Quays and Rotherhithe.

The premises are situated approximately 0.6 miles/12-14 minutes' walk from South Bermondsey Station, which provides National Rail services and 0.9 miles/18-20 minutes' walk from Bermondsey Station (Jubilee Line), offering direct London Underground connections
