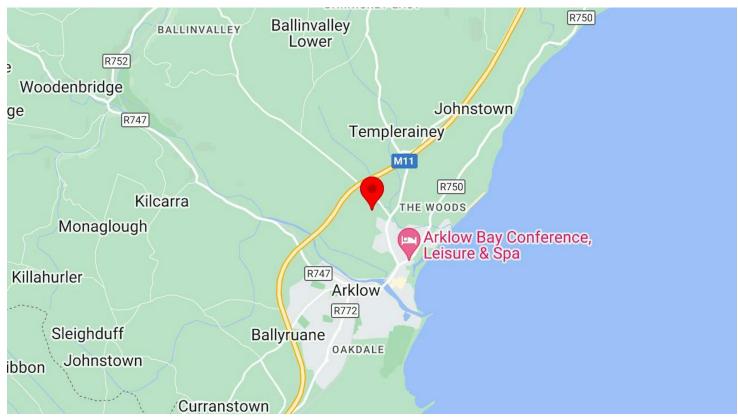

#### Location

Arklow Hublink is located within Kilbride Industrial Estate, which is an established business park on the outskirts of Arklow, Co. Wicklow. Arklow is a seaside town, positioned equidistant between Dublin City and Wexford Town, which are located approx. 70km to the north and south respectively.
