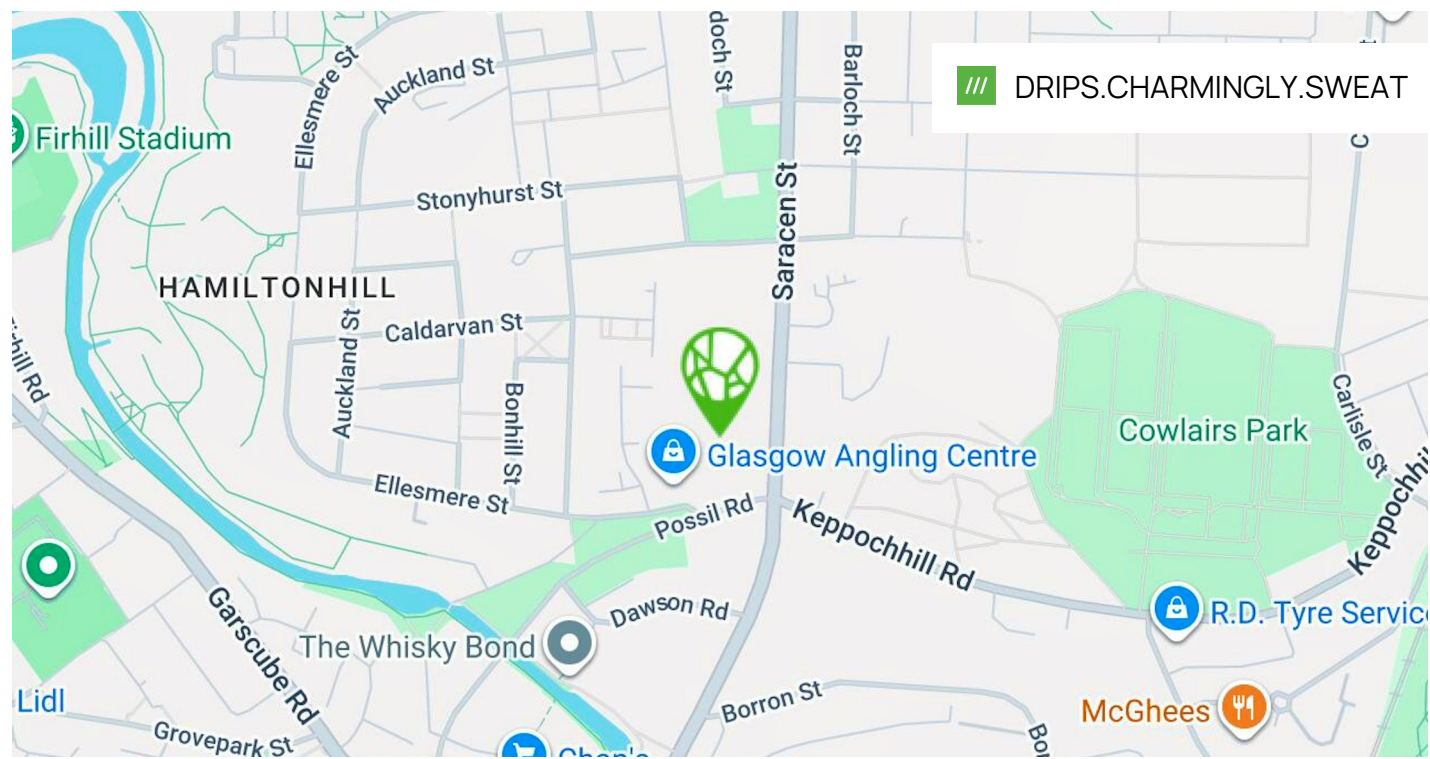
## LOCATION

Glasgow is the most populous city in Scotland, located on the banks of the River Clyde in west central Scotland. The property is located within The Point which is a popular and established business location. The Point sits around 1 mile north of Glasgow City Centre within the Port Dundas area of Glasgow at the central meeting point where Possil Road, Craighall Road, Keppochill Road, and Saracen Street converge in a four-way intersection. Nearby occupiers include Toolstation, Screwfix, Glasgow Angling Centre and Euro Car Parts.

## DESCRIPTION

The subjects comprise a mid terraced rectangular shaped industrial unit of steel portal frame construction within an established trade, retail and leisure park.

Access to the property is gained via twin glazed pedestrian doors. Internally, there is a waiting area, reception, admin offices and kitchen to the front. The soft play and activity space benefits from a private function area and cafe with tables and chairs surrounding it. The commercial kitchen which, as expected, is fitted out to a professional standard with extract ventilation and a range of stainless steel sink units, utility basins and fitments. Customer welfare facilities are provided. On-site car parking is available which is shared in common with the adjoining occupiers.
