LOCATION

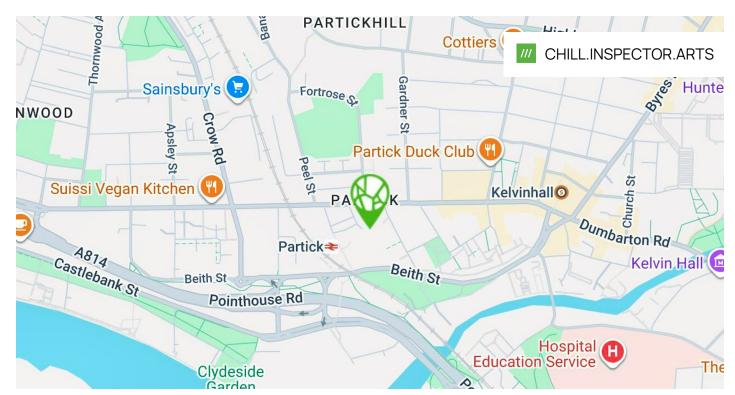
Glasgow is Scotland's largest city and is situated in the central belt and on the west coast. 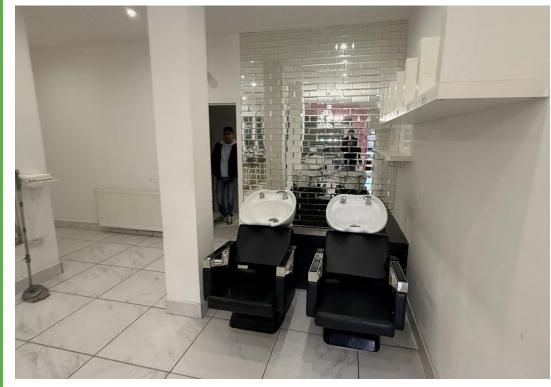
