The property is situated within Devonshire Business Park in Basingstoke which is a popular industrial location 1.1 miles north west of the town centre. The mainline railway station and Junctions 6 & 7 of the M3 are both within a few minutes drive. Basingstoke has direct links to London Waterloo Station which takes approximately 45 minutes, as well as good access to the South-Coast and West Country too.
