Description

Hastingwood Business Centre is an established mixed use commercial site located in a well positioned semi rural location.

There are two suites available. A bright ground floor space, suitable for up to 4 people, and a first floor suite, accessed via a set of stairs. Both suites have excellent levels of natural day light, oil fired central heating, Digi lock entry system and 24 hour access. Suitable for a wide range of uses including an office use or for storage.

A small shared kitchen is located on the ground floor with tea making facilities and WC.

Location

Hastingwood Business Centre is located close to Junction 7 of the M11, with access south towards the M25/London and north towards Cambridge and Stansted. Harlow town is approximately 4 miles away, whilst Epping town is within a 15 minutes drive. There is a mainline station into London Liverpool Street (30 mins) from Harlow Town Station or Epping tube Station, which is at the end of the central line.
