Description

The property is a Grade II listed building comprising a ground floor retail unit fronting The Borough, the prime town centre shopping location. The property benefits from open-plan retail space with ancillary storage and WC facilities to the rear. Character features include attractive exposed wooden beams.

Location

Farnham is a thriving retail destination known for its combination of historic charm and modern amenities. The town was ranked in the top ten best places to live in the South East in the annual Sunday Times Best Places to Live guide. Around 34% of the population falls within Class A/B, over 50% higher than the national average, highlighting the affluent local catchment.

The property is situated in a prime position on The Borough close to a mix of national and independent retailers and restaurants. Farnham benefits from excellent connectivity, being well-served by a network of major roads including the A31 which links directly to the A3 at Guildford and the Blackwater Valley route (A331), providing dual carriageway access to Junction 4 of the M3 at Frimley. The town is also served by a mainline railway station offering a direct service to London Waterloo in approximately 55 minutes.
