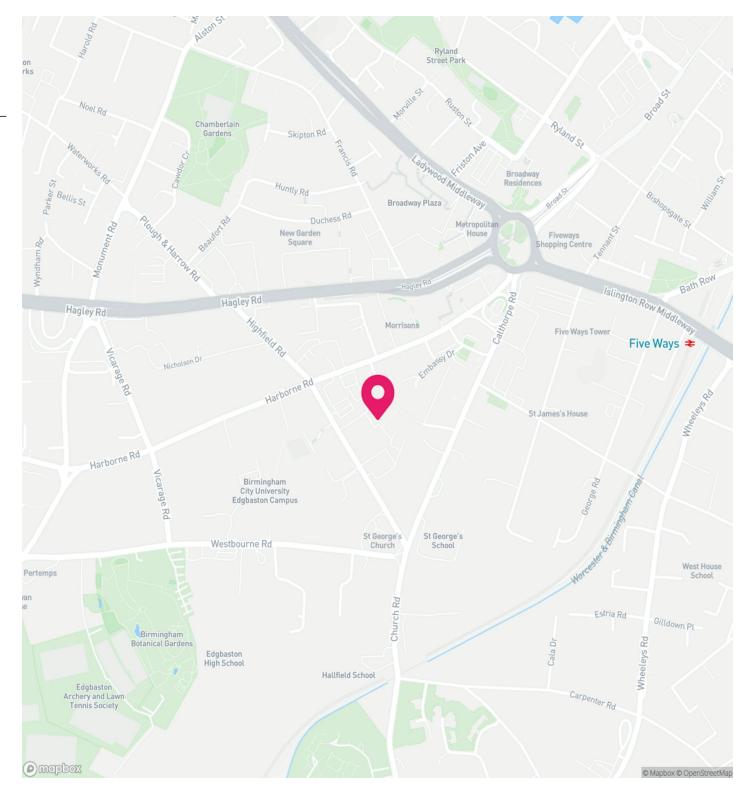
LOCATION

The property is prominently situated within the Edgbaston Commercial District at the heart of Edgbaston Village - a vibrant leisure and lifestyle hub just outside Birmingham's Clean Air Zone (CAZ).

Five Ways Railway Station is also within walking distance, with direct trains to Birmingham New Street taking just 3 minutes. Well-served by local bus routes and conveniently positioned close to the A456, the inner ring road, and major motorways (M5, M6, and A38), the location ensures easy access throughout Birmingham and beyond.

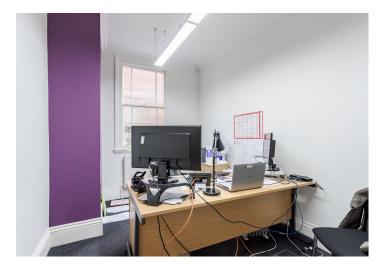








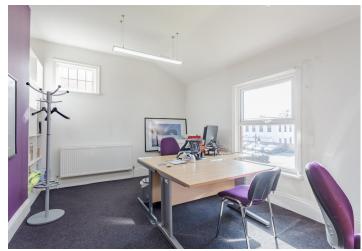














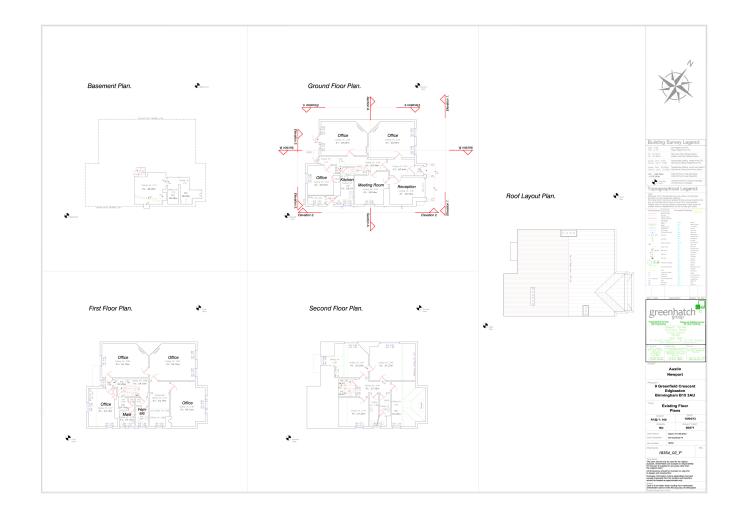
