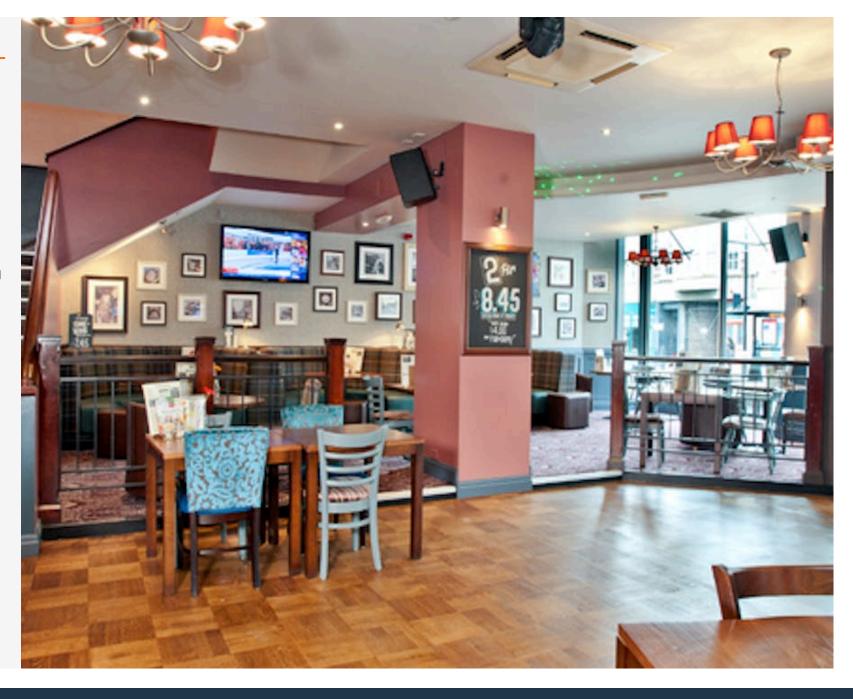

- Peterborough attracts both domestic and international visitors to its historic city centre with Norman Cathedral













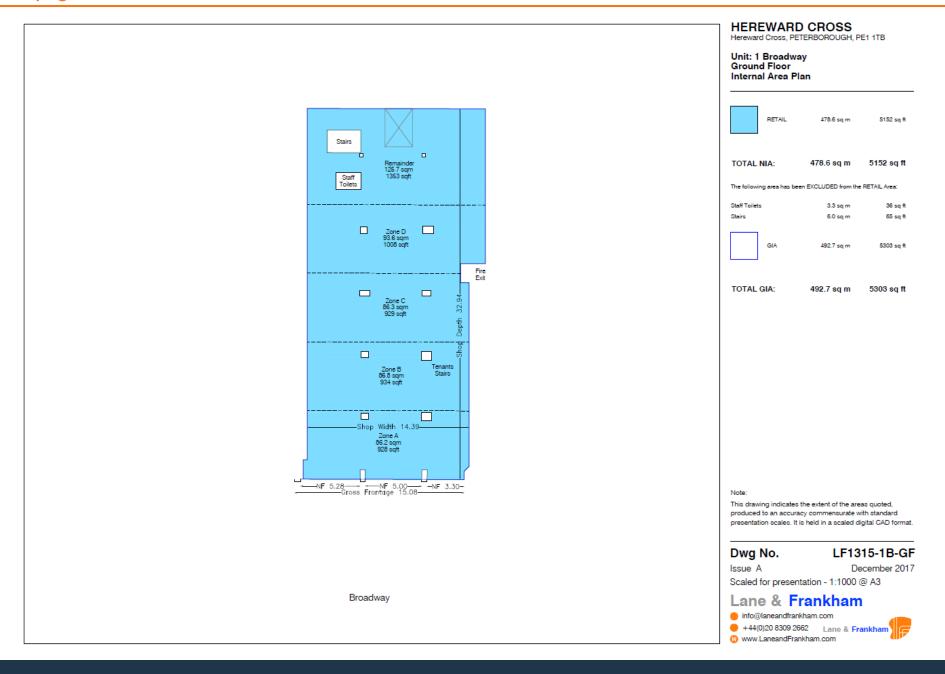


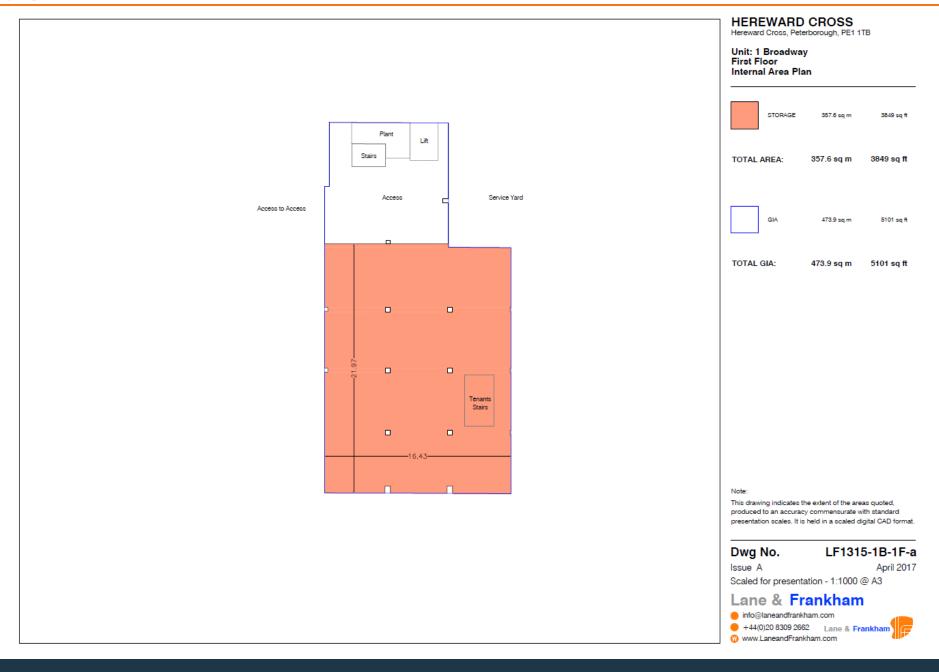




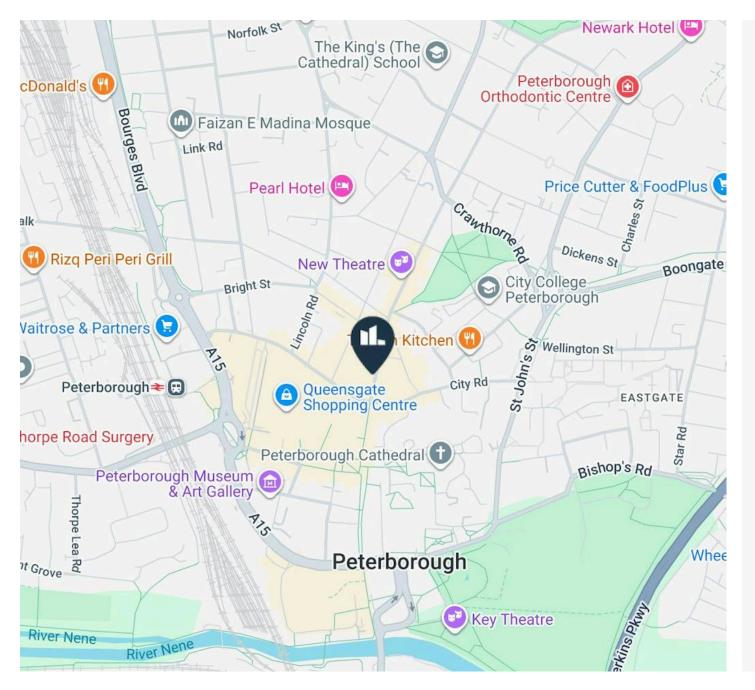












Location
